Remembering Larry and his "Rhymes and Reflections"

Farewell, Old Friend

Sadly, our long-time friend and dialogue "Poet Laureate" and columnist Larry Vaincourt passed away, on April 20th. Larry had been writing in the English Quebec media for many decades and was published in papers across Canada and the U.S. He is greatly missed by his family, friends and loyal readers.

Larry was born in 1923 in Upstate New York and grew up as a farm boy, in the rural setting of Covey Hill in southwest Quebec, where he lived until he joined the Air Force in World War II. After serving as an aircraft mechanic and part-time entertainer, he returned to Quebec in 1946.

Larry and his wife Doreen were married in Smiths Falls, Ont., on Labour Day, Sept. 1st, 1951 and they raised five sons: Larry, Wayne, Mark, Randy and Scott. The family gathered to celebrate their 50th Anniversary in 2001. A photo of the couple graced the cover of dialogue in Vol. 15, No. 2 (July 2001). An article in that issue by Randy noted, "A sense of family, a love of music, a respect for nature;

these are the gifts our parents gave us."

Larry had a varied career, which included working as a logger, news photographer (ABC News Pictures), circulation manager (Montreal Standard), civil servant, and metalurgical photographer (Rolls Royce, Canada). In 1963, Larry opened his own camera store and photo studio, which he operated in Pointe Claire (West Island of Montreal) until 1983. For several years after that, he had a photo studio in Two Mountains, during which time his writing career began to take shape. He first became a regular columnist with the Lachute Watchman.

Larry's poetry, especially, was often read on Bill McNeil's "Fresh Air" program on CBC. Mr. McNeil commented about Larry's writing, "He can write like an angel and kick like a mule. That's Larry Vaincourt. When I first discovered him in the Ouebec weeklies, a few years back, I was truly excited. Time and numerous columns later, I still feel the same way. In prose or verse, Larry proves time and again that he's one of a kind. He's a breath of fresh air. "

With the help of *Dialogue*, Larry's first volume of prose and poetry, entitled "Rhymes and Reflections," was published in 1991; his second volume, "Don't Burn the Biffy," in 1995.

One of Larry's poems, Just a Common Soldier, caught the imagination of thousands of people around the world and was published in many venues world-wide. This poem was first published in 1987 in Larry Vaincourt's newspaper column in the Lachute Watchman.

Larry received the "2004 Column of the Year Award" from

the Quebec Community Newspaper Association. In July 2004, he published his third book, "Just A Common Soldier and Other Poems," a collection built around his most popular poem. The original poem is featured on his website, where his third book can also be ordered:

The Words Live On

My father was known by a few different names. To his parents and siblings he was Amos, most of the world knew him as Larry, but to his family he was Lucky, a name he gained while boxing during his Air Force days. In first grade the teacher asked me to draw a picture of our family, and write each person's name underneath. I drew myself, my four brothers and our parents, then dutifully printed their names below. My mother, Doreen, and my father, Lucky ...spelled in my 7-year old manner as L-U-C-Y. When the teacher asked, "Isn't

Doreen & Larry in 2001 that your mother's name?" I assured her that no, it was indeed my dad. She seemed confused but let it

pass. Only years later did I realize how much on the cutting edge of modern relationships I had been that day.

Dad was a Depression-era farm boy, born and bred. He never lost his love of the outdoors, and instilled that same feeling in his children. His family was French Catholic, and Dad believed his surname was the more common "Vaillancourt" until he entered the Air Force in World War II and discovered the Priest had actually written "Vaincourt" on his baptismal certificate. When Dad was only four years old, he lost his own father in a tragic accident. Eventually his mother remarried a wonderful man named Dennis McCarthy, who raised Dad and his siblings, so by the time my brothers and I came along our French grandmother had become known as Grandma McCarthy. Multiple name spellings and families full of unrelated accents – all part of life in Quebec.

His childhood was poor, but he was blessed with the greatest richness in the world; the love of music. Dad learned ⇒ guitar and harmonica and as a young man he played in dance bands; it seemed my father could play just about anything with strings on it. He passed that love on to his children, with all of us playing at least one, and some several, instruments. Dad used to play albums of French-Canadian fiddle music, loudly and with great enjoyment, which once inspired our mother to exclaim, "And your father says Rock and Roll music all sounds the same!!"

Dad served in the Royal Canadian Air Force during World War II, where he wound up performing in a musical review entitled "Ham and Legs." As he said to me years later, "Guess who the ham was?" Thinking back now I'm rather relieved that he hadn't been the other part of that duo.

After the War he returned to Montreal, became a photographer and eventually met our mother, Doreen, who became his wife of 58 years. 58 years – now that's a testament to love. A French Catholic boy married an English Protestant girl, which was the 1951 version of a mixed marriage. When I was little I asked my father what the difference was between the two faiths, and he said, "I don't know, I always

When I was little I asked my father what the difference was between the two faiths, and he said, "I don't know. I always thought there was only one God." A simple, easy to understand philosophy that I carry with me to this day.

In 1976 my brothers and I threw them a 25th Anniversary party, then a 50th Anniversary party in 2001. It seemed to me that no time at all had passed between the two events, which I'm certain is how they felt about their almost 6 decades together.

Dad once told me that because of his work schedule, he felt he hadn't spent enough time with us when we were growing up. The strange thing is that we never felt that way. Sometimes he would sing us to sleep with his guitar. I can see him standing next to our bunk beds, strumming and singing funny songs that remain in my memory to this day. Every kid enjoys a lullaby, but we had an actual concert performance to send us to sleep.

When I was small I remember being amazed that my father could fix absolutely anything. From toys and bikes right up to appliances or cars, Dad seemed to know how to make them right again. As I grew up I came to realize that in most areas, my Dad was self-taught. Always fascinated by how things worked, he could dismantle, examine, learn what he could about something, and then apply that understanding to the next thing he worked on. He also kept every piece of equipment he ever owned or dismantled. We once found a carburetor for a 1930 Chevy out in our shed, which I'm certain he kept just in case they ever started making that model again.

Dad enjoyed driving, and in the past few years he became a common sight on our local streets, zipping around on his electric scooter. He'd head up along the bicycle paths and often be gone for hours, causing our mother to become frantic. He decided that the scooter's horn wasn't loud enough, so he installed a car horn instead, which no doubt

he found out in our shed. I often thought he did it just to watch the reaction of bike riders when he'd sneak silently up behind them and give it a blast.

After Dad retired from the photo business, he developed a new passion: writing. He quickly became a columnist for the Lachute Watchman, where his columns ranged from heartwarming stories about farm life and anecdotes from his military experiences, to attacks on one of his favourite targets, Quebec politicians. His writing soon ended up in other papers and magazines, including of course, Dialogue. His columns resulted in three published anthologies of poems and short stories. Over the past year he had been writing a novel, entitled "Harper's Hill." No, it's not a satire about the government in Ottawa, but rather an exciting murder mystery set in the early 1950's. I'm pleased to say that about a month ago. Dad sent me the finished manuscript to proofread. It's his final offering to the literary world. Unless you count the poem he wrote just a few weeks ago which we found in his office the other night, entitled, "When Grandpère Cut The Cheese."

Then one fateful Remembrance Day in 1987, he decided to write a poem to honour all veterans. Entitled "Just A Common Soldier," it was published, then soon consigned to one of his many scrapbooks. A few years later I was shocked to read several stanzas of the poem in Ann Landers syndicated column. Upon closer research we discovered this poem had somehow been reprinted hundreds of times around North America. The American Legion had picked it up and was putting it on display in their branches. Suddenly it was being read on national radio broadcasts every U.S. Memorial Day, an event that continues to this day.

Britain and Australia followed suit on their Remembrance Days. Since then the poem has appeared in countries around the world, as far away as India, New Zealand and South Africa. Requests for reprints continue flooding in; one British university uses it as required reading in a literary course. Its words have been altered slightly to better reflect different countries of printing, and "soldier" has been changed to "sailor" for that arm of the military. Last July 4th, 2008, it was permanently engraved into a marble monument at West Point. The poem's reach has been both staggering and a lasting legacy to my father.

Dad shared his laughter and thoughts with the world, and the world continues to respond through letters and emails. What greater gift could he have left our family than the knowledge that his words have brought joy and comfort to people all around the globe. He made us all so very proud and we will miss him forever. He was my inspiration, my friend, my father. – *Randy Vaincourt* *

Where has my Canada gone? Jurgen Vollrath, Embrun ON

My father arrived in Canada in spring of 1955. He was 29 years old and had about \$50 in his pocket. He worked at several jobs and by September of that year was able to send for me and my mother.

Jobs were something that you could get on your way home from your job. Jobs had no restrictions of language, colour or ethnicity. There were no quotas for jobs. The only quality required was a willingness to work and dependability. People were interactive and appreciative of commitment to hard work and life was tough but enjoyable. No matter what language you spoke, you managed to communicate with your co-workers through the common thread of being industrious. It was fun to work out language differences on a personal level. No government involvement was required. The old adage that you worked hard and you played hard was lived out and although nothing was easy, there seemed to be a much stronger work and play ethic.

Everyone looked forward to Friday night as the start of the week-end and we knew that Sunday was a day of rest from the toils of the week and perhaps the overindulgence of that Friday and Saturday.

True democratic elections, where all the parties were diametrically opposed in opinion and thought, were talked about with vigour. Our political system, although not perfect, was a beacon of hope for people throughout the world. People left oppressive regimes to come to Canada where they could feel a part of the process to a better life. When the citizens went to the poll booths they had a clear choice. The CFF (currently the NDP) were clearly to the left of the political spectrum. Strong union support and distinctly socialist, you knew who they were. The Progressive Conservatives, on the other hand, were the party of individual responsibility and capitalist to a fault. The Liberals were very clearly the party in the middle. They appealed to the "light" conservatives and "responsible" socialists in our country and won a lot of power based on that appeal.

There has been a shift, over the last 40 years where the quest for power has totally diluted our failing political system. There is no more talk at the dinner table about the qualities that differentiate the parties in power. There is, however, plenty of talk about not voting because there is no more clear choice of direction. The pendulum has swung so far to the left that, the electorate, can no longer establish a distinction between the parties.

That is not to say that there are no differences in platforms, as there certainly are, however, those differences are no longer as far apart as they once were. All of them might as well wear red ties.

We are losing privacy in a stealthy fashion

Re: The Surveillance Society, Jan. 31 to Feb. 5

Congratulations to (*Ottawa*) *Citizen* writer Don Butler for explaining so vividly the dangers of modern surveillance technologies.

Whether the goal is to deter crooks and terrorists, enhance marketing efforts, ensnare cheating spouses or control wayward teens, proponents of the surveillance society offer many justifications for monitoring and tracking the lives the others.

The technology to scan and record people's identities and movements exists, so why not use it to enhance the safety, comfort and convenience of Canadians? By extension, defenders argue, those who have nothing to hide have nothing to fear.

In fact, as the *Citizen* series clearly showed, nothing could be further from the truth. Ordinary Canadians going about their daily lives have everything to fear from governments and other organizations that monitor and record their day-to-day activities.

Privacy is an important human right that is tied to personal

autonomy, freedom of thought and speech, and liberty of movement and assembly.

If we were to lose that right in one cataclysmic instant by government decree, for example - there would be revolution in the streets.

The unfortunate reality is that we are, indeed, losing it, but in a stealthy, incremental fashion that most people barely notice, let alone protest.

Unlike Nazi Germany, Soviet-era Russia or fanciful fiction, there is no single Big Brother with unfettered oversight of our lives. Instead, the threats are less obvious and originate from all directions.

The excellent series (in the Citizen) underscored that the threats to privacy are real and the dangers imminent. As individuals and as a society, we cannot afford complacency. It is urgent that we become more informed about who is collecting information about us, when and why, and that we question any surveillance activities that encroach on our profoundly valuable right to privacy.

to December 2008, in a lecture series on Studies in Propaganda, at the <u>Free University of Toronto</u>. The weekly sessions at the St. George Campus, Sandford Fleming Building, covered topics including:

- America A History of Violence: presidential assassinations and the ownership of the money supply;
- 9/11 Revisited: Scientists and engineers proved to us that this mass murder was an inside job; in the U.S. the truth is ignored, in Canada, it's no defence.

Presentation to House of Commons Finance Committee re the CPP Subject: A review and appraisal of the investment model and practices used by the Canada Pension Plan Investment Board (CPP IB)

[May 7, 2009, Ottawa] The formation of the CPP IB as an independent corporation had to have occurred after representations were made that monies surplus to the immediate needs of CPP could be invested in other than government bonds

to the significant financial benefit of plan members.

Its (CPP IB) legislated mandate is "to act in the best interests of CPP contributors and beneficiaries, to maximize investment returns without undue risk of loss, and to take into consideration the CPP's funding status and ability to meet its obligations" (CPP IB, 2002a,p.9).

Beginning in 2002 I began expressing my concerns to the Finance Ministers of the day. In point form my worries then and now are:

The CPP IB has or might become an "investor of last resort" for failing companies.

Equity investments represent an elevated level of risk incompatible with the "mandate" and not understood nor accepted by the contributors/beneficiaries.

Private equity investments (more correctly described as speculations) have no place in the CPP Fund as valuations are not determined objectively when either purchased or valued.

Liquidity of many of the investments at the CPP Fund will be compromised and often unavailable.

Attached under Tab 1 are copies of my representations, predominantly to the Ministers of Finance and beginning with a letter dated January 14, 2005 to The Honourable Ralph Goodale and finishing with a letter dated February 18, 2009 to The Honourable James M. Flaherty. In each letter the theme is the same but I have introduced examples of inappropriate investments (speculations in my judgment) which support my concerns.

Attached under Tab 2 are copies of articles and notices of these inappropriate investments. To help appreciation of the nature of a financial investment and a speculation a short definition is included. A speculation is where there is no promise of safety of principle and a financial return on the money such as interest.

Posted February 28, 2007 was a report titled "CPP Investment Board dips toe into US real estate market". The US\$500 million was characterized as a "first major bet". In contrast, and well before this transaction, the Governor of the Bank of England publicly cautioned British banks

to be prepared for a 40% rollback in real estate values. Additionally the CPP IB would have had knowledge of the US based Case-Shiller housing index. In early 2007 the index value was at an all-time high of 210 when the steady state is around the 100 mark.

Posted in the *Globe & Mail* on May 5, 2008 was a story about the CPP IB speculating on the prospect of building a very controversial power transmission line in Patagonia. Posted by accident on August 18, 2008 in the *Globe &*

Mail was a comment about the CPP IB speculating by trading in ABCP and some New York crafted toxic paper. Posted on March 30, 2009 by the CPP IB was notice that it intends to acquire 100% of issued shares of the Macquarie Communication Infrastructure Group. This takeover is to be at A\$2.50 when the open-market valuation has been under A\$1.00. If that isn't bad enough, the CPP IB intends to stay in a business relationship with the Macquarie management who has been singled out for serious criticism by RiskMetrics Group in New York.

This has all the appearances of a seller in search of a foolish buyer. Making matters even more troublesome, the CPP IB has concurrently announced its intension to finance this and other speculations with borrowed money. Conclusions

The CPP IB engages in speculations that are incompatible with the legislated mandate. In the future these speculations will visit more losses on the CPP Fund than its beneficiaries wish to tolerate.

Accountability to the beneficiaries is minimal to nonexistent. Reliance rests entirely on the practice of full disclosure. There is virtually nothing the beneficiaries can do to effect changes to the investment practices of the CPP IB. The use of non-publicly listed assets sabotages confidence in

the financial statements of the CPP Fund, particularly when they are "unaudited" for quarterly reports. The disclaimers etc used by the annual report auditors, Deloitte & Touche, do little to improve confidence in valuation accuracy.

Suggestions

Initiate a request to have the CPP IB suspend new investment projects and seek to have equity assets sold.

In the likelihood that a less assertive action is preferred, the Committee could conduct a test. It could ask the CPP IB to volunteer 20 private party investments. After creating a short list from those 20 then ask the CPP IB to canvas for verifiable and unconditional bids for each asset on the short list. It might even be useful to accept the bids as final proof.

By this exercise the Committee would be in a better position to judge the veracity of the about to be released financial statements.

Thank you for this opportunity to present my concerns and ideas. Please appreciate that I am representing more beneficiaries than just myself.

- Erik Andersen, Gabriola Island BC Some observations by Erik, following the Committee meeting:

[EXTRACT] I was disappointed when I heard Mr. Menzies suggest that everyone was caught by surprise when financial conditions turned sour and pension plans were adversely affected. I think the whole of my end of the room as a person said "not true". For myself, I began expressing my concerns in 2002 by letter to our government. On May 5th Mark Brandly posted an article titled "Should People Just Ignore Economists?" on the Von Mises site. His article was in reply to a BusinessWeek article of April 27th titled "What Good Are Economists Anyway". After a long lead in, Mark gets to his main point. "BusinessWeek has done us a favour by pointing out that most economists continue to accept the very theories that prevented them from anticipating the financial collapse. However, the magazine errs in concluding that we should now listen to those same economists. It would make more sense to ignore those economists that not only failed to predict but also had a hand in creating the crisis."

I would say it is entirely logical to suggest that in the absence of giving warning that is on the record, those economists that failed to meet *best practices* professional standards should consider doing other work they maybe better suited for.

Another missed opportunity (at the Committee) was to broaden the discussion about actuarial best practices. The Committee was fortunate to have Mr. Bernard Dussault at the table. This is a very knowledgeable person to ask about the assumptions made that lead to an estimate of the soundness of the CPP Plan and others.

It was my sense that all those appearing shared a huge passion for the topic of pensions. This passion did not seem to be shared by the Committee.

I was grateful to Mr. Robert Carrier for his understanding that the CPP IB system design is flawed and will produce distasteful results. The way the CPP IB functions it is isolated from the contributors/beneficiaries so it cannot meet the standard investment rule of "know your client". The CPP IB design is also flawed by the fact that it both selects and values the investments to be made and then has dominion or influence over the subsequent valuations. A very questionable practice that needs correction.

<u>Postscript</u>: The only new development is the delay in reporting the year end results. The CPP IB web site still indicates mid May but the CEO says it will be end of May. We all maybe in for a "Nortel" experience and the delay may be driven by the timetable for the sitting of Parliament (i.e. when in recess). Erik

Declaring the Times on Parliament Hill, April 29, 2009

I committed treason last week, in front of a throng of RCMP and CSIS goons outside what is called the Canadian Parliament.

"I just committed treason here. So arrest me! You say you want to bring me in for questioning. So here I am! But I have some questions for you, too: like why you refuse to bring known criminals to justice for the murder of 50,000 aboriginal children!"

None of the cops responded. They even looked vaguely embarrassed. But the sightseers seemed shocked. It was like that on April 29 in Ottawa, on the illegally occupied and never-treatied Algonquin land where Parliament perches.

It was the same day that a guy who calls himself the Pope was pretending to be sorry for what his church did to innocent children, and dishing out lies to his deluded followers. A bunch of us thought it was a good day to respond.

The sun smiled on the twenty or so of us, mostly Mohawk traditionalists from Kahnawake, as we crossed the river into Ottawa from the Quebec side. Under a banner that

declared, "All the Children Need a Proper Burial", and held aloft by three Mohawk children, our little army descended on three of the architects of genocide in Canada: Indian Affairs, the "Supreme Court", and Parliament itself.

Our first stop, at Indian Affairs, featured us trying to speak to manicured ex-Indians in fancy clothes who gaped at us from behind their office windows, or

hurried past us lest their white masters spotted them listening. Two of them stood in the doorway and smirked at us. But many others stared soberly at the words on our banner, and at the little ones clutching it.

It was these children who drew all the quiet stares all along our route. The kids led us down the street and over the bridge. Police cleared the way for us, lights flashing, as we were accompanied too by so many spirits.

"Assholes!" yelled a white cab driver at us, as Stuart Miyoh of the Mohawk Traditional Council exhorted those nearby to remember the disappeared children. The silence that echoed back at us was deep, as from a grave.

"Truth" and "Justice" were the words emblazoned on the edifice of the Supreme Court as we fanned out on its steps. Taking them at their words, one of our people, a young native woman, said through the bullhorn,

"All we want is justice, and not to be criminalized whenever we defend our sacred mother earth. But this court makes us the wrongdoers and lets logging companies rape our mother. We'll never get justice in Canada's courts."

I asked her for the bullhorn and began to name the names of the judges who had been accused of pedophilia in Canada. One cop gawked at me, shocked.

"That's the bravest thing I've ever seen" the woman told me, as the cops looked troubled. But one of them approached me as we neared Parliament and said,

"People can hear you better if you're right up on the steps". Smiling, I felt the whole shaky edifice crumble a bit. That's when I launched into my call for a new republic in front of the phalanx of mounties.

Stuart was busy speaking to a group of high school students

on a Parliamentary tour, declaring,

"You kids should know that people your age were murdered every day in the Indian residential schools, 50,000 of them! Learn what your country is really like. Read hidden from history dot org and stop supporting murderers in high places ..." An outraged teacher began shooing the dumb struck stu-

An outraged teacher began shooing the dumb struck students away from us, his arms stretched out like a panicking

mother hen. But the crowds were forming around us by then, and for a half hour we stood and waved our banner and showed the country its lies and its crimes.

I was flying by then. During one of my speeches, when I got to the part about the Crown being a fictitious body with no jurisdiction over us, one of the bald-headed suits in shades with a wire in his ear sauntered over to me and said that I

could expect to receive a warrant for my arrest soon.

And so it goes.

the Children

Near the end, we all decided to return to the same spot in even greater numbers on June 11, the first anniversary of the Hollow Apology of Steven Harper to survivors of the residential schools genocide.

Carry it on.

Peace, Order, and Good Government?

I came to Canada as a young man and not having grown up here found the phrase used to describe the Canadian system, "peace, order, and good government", sort of odd and charming at the same time. How modest, just like Canadians, I thought.

That was before I'd been here long

enough to know some Canadian history and realize that within this phrase was a world of political realities not spoken of in polite company. The wars against Native peoples, for example, combined with the cultural genocide of the residential schools seemed to be forgotten by most citizens and government alike. But for the victims, the phrase had a bitter irony. Part of the irony is that the oppression of Native peoples is not an historical mischance or ancient history, but a continuing pattern highlighted by unleashing the RCMP and military against Native protests at Oka, Quebec, and William's Lake, British Columbia.

The phrase seemed to me to be getting a bit shopworn as I learned more: the internment of Germans and Ukrainians in World War I for the crime of being German and Ukrainian; the obscene Chinese "head tax"; more internment, this time for Japanese-Canadian citizens in World War II; the seizure of the Douhkabor children in the 1950s; the War Measures Act of 1970... and the list goes on.

A political acquaintance finally put it all into perspective. What it really means, he said, is this: "You keep your peace, we'll give the orders, and we'll call that good government". I laughed the first time I heard this. If you're white and middle class or higher up the food chain, it's still easy to think that our government exists to serve us. Try, however, telling that to the 3,000 or so homeless on Vancouver's streets, or the thousands more across the country. Try telling that to Native peoples living in housing so encrusted by mould that they run the risk of deadly fungal infections. Or how about the hundreds of so-called "illegal" migrant workers recently scooped up in Toronto, or Tamil -Canadians who have watched their government remain silent as the Sri Lankan army slaughters their former countrymen and women, or the Lebanese-Canadians or Palestinian-Canadians who saw the same government's stark indifference to Israeli massacres of civilians? So much for the "peace" part of the phrase.

How about "order"? Stay tuned to next year's Olympic Games which will feature 15,000 police and soldiers locking down Vancouver for the International Olympic Committee's (IOC) circus extravaganza. There will be "order"

alright, complete with preventative arrests, continual harassment of anti-Games activists and Native peoples, more homeless "red zoned" and swept aside and all so that the party for the developers and their political buddies can go on. Tens of thousands of ordinary people, unable or unwilling to celebrate this corporate invasion will find their lives massively disrupted for 51 days. Do you need to keep your business running, or get your kids to school or the doctor? Tough beans. "Work from home", the Vancouver organizing committee for the Games tells us. Take your vacation, whatever, but the Games count for far more than you and your petty problems and will go on regardless of how much it messes with your life.

This brings us to "good government". Want to know just how good it really is? Try a simple exercise to find out: send a Freedom of Information request for anything you think you deserve to know about to your local municipal or provincial government or an Access to Information request to any federal agency. Good government, after all, is supposed to be open, transparent, and accountable government, right?

Do it if you haven't, because in this simple act of citizenship lies a stunning surprise: the governments don't really work for you and they have no intention whatsoever of letting you peer behind the curtain. I've done dozens of requests to every level of government over the last few years in an ongoing quest for information about Olympic security costs. Every time, from every agency, the same pattern plays out: endless delays, attempts to get me to pay for "staff time" to find the relevant records, more delays, and when material eventually arrives, page after page blacked out (or the new trick whited out since it doesn't look at bad on TV). Every last agency, every last one does this. Two recent examples will make the point: RCMP, after a year, finally released to me some documents showing that they have been hiding the security costs for almost two years after then realized that the original security budget for the 2010 Games was a utter fraud perpetrated by Vancouver's Olympic Bid Corp in 2002. Three levels of government literally conspired to prevent this information from coming out and discussed how to manage pesky questions from the media. And here is the latest: I had written to Fisheries and Oceans Canada some 22 months ago asking them to please tell me what the Coast Guard's budget would be for 2010. They refused to release anything, citing Privy Council confidentiality. I complained to the Federal Information Commissioner and here is what finally came

back from them: Fisheries and Oceans gets a complete

pass under subsection 69(1) of the Access to Information Act because, for reasons we'll never know, the agency thought what they had planned was so secret that the Privy Council could know but the rest of us couldn't and the simple act of waving the information past the Council made it off limits forever. Remember, I hadn't asked where the Coast Guard was going to put their boats, merely how much it was going to cost.

When you can't even find out how your own government is spending your money, I'd say there is a fundamental breakdown in democracy.

So there you have it: No peace (unless you are amongst the privileged like the IOC and their hosts), no order (unless you do precisely as you are told), and certainly no good government (unless you think that governments that operate in secrecy are good).

This brings us back to my friends joke: "You keep your peace, we'll give the orders, and we'll call that good government". I thought that was funny once. I'm not laughing now, but I am thinking of ways to make governments actually act in ways that serve the interests of all, not just the elite.

Canada: Open for Global Business

Canada's Free trade deal with Colombia

Canada's recent signing of a Free Trade deal with Colombia, of all places, should lift more than a few eyebrows. In Canada, in the aftermath of the Free Trade deal (1988), a controlled press and lavish propaganda disguised the reality of the loss of 400,000 manufacturing jobs as well as the disappearance of much of our industrial facilities. Most of our exports now are basic and nonrenewable.

Colombians, on the other hand, are well-acquainted with the pitfalls of free trade in South America, and may not be in the mood for any more of it. It's important to remember that civil war has been a fact of life in Colombia for generations. It is possible the main reaction to the imposition of free-market philosophy will be to rejuvenate the F.A.R.C. (Revolutionary Armed Forces of Colombia.)

Colombia has a horrendous human rights profile. One report cites the assassination of over 2600 union activists in the last thirteen years. It is currently estimated that up to four million displaced and homeless Colombians exist within the country. This may be a recipe for peace and prosperity, but it's not likely.

On a more positive note, I was pleasantly surprised recently to learn of a common sense suggestion by Prime Minister Harper on the subject of the long gun registry. I believe he correctly identified the registry as useless and recommended its elimination.

The March 22nd version of CTV's question period had an interview with Michael Ignatieff, leader of the official opposition in the House of Commons. When asked for his opinion on the gun registry elimination, Mr. Ignatieff stated that police chiefs made use of the gun registry on a daily basis to assess the hazards in a home invasion, if required. I'm no expert on the matter, but doubt if I could muster up much faith in police chief who trusts the Canadian gun registry to be accurate. I'd have even less faith in a politician who recommends the custom.

P.S. The original version of the enclosed letter has a somewhat embarrassing history, in that I mailed out a couple of

dozen copies, including a dozen or so to Federal politicians, before learning that Colombia is not spelled Columbia. The Conservative caucus might think I'm attacking their Holy Grail, Washington D.C. .

Europe and Canada and the Global Business Agenda

In a NYTimes.com article, published May 5, 2009, **Bill Emmott and Roy Maclaren** reported: "Amidst dark mutterings about the rise of protectionism in global trade the good news is that the European Union and Canada are today launching 'comprehensive trade and investment negotiations,' leading to a free-trade agreement."

The article affirmed that the European Union and Canada "are on the move" in their negotiations. Following the 2008 announcement of a joint study of the trade and investment benefits of further liberalization and harmonization between them, it seems that what is in the works is the "negotiation of an ambitious trans-Atlantic agreement that would go beyond the terms of more conventional free trade agreements (such as the E.U. already has with Canada's NAFTA partner Mexico). In addition to the removal of all tariffs, the new agreement will take in a wide diversity of influences on trade. These will include the free movement of skilled workers, the opening up of government procurement, and the elimination or harmonization of a range of regulations..." The authors note "the reasonable expectation that the talks will go forward promptly, outstanding issues having been identified if not settled in advance. One such question, now resolved, was Europe's need for assurance that, in the Canadian federation, all levels of government would implement the agreement. The conclusion of that question had meaning beyond the bounds of the E.U.-Canada agreement. It will arise again when Europe embarks upon negotiations with the federations of Australia and the United States."

Canadians may find themselves wondering just how their federal government could have committed "all levels of government" in Canada to implement the clauses they are negotiating. Have all other jurisdictions – provincial, regional, municipal, etc. – in Canada become totally powerless? Or have the provinces, perhaps, already been persuaded to agree in advance?

Another question Canadians may ask themselves: Is the EU-connection one of the reasons being used by the federal government to persuade provinces to adopt more support for and use of French?

One thing is certain, Canadians at large are not being asked for their opinions on the continuing emasculation of our nation's ability to put the needs & aspirations of Canadians ahead of the demands of global business interests.

Canadian Government Policy re Israel

A Vietnam Veteran discusses Canada's role in Afghanistan

"The integrity of this mission for Canadian Forces has been lost"

These remarks were prepared for public delivery to the ''Kamloops Walk for Peace, Environment and Social Justice,'' on May 2, 2009.



John McNamer, Kamloops BC

I am a Vietnam veteran, having been drafted and sent to Vietnam to serve with the U.S. Army's 4th infantry division, so my particular focus these days is on matters of war and peace.

After years of personally wrestling with the tragic consequences of having been involved in the horrific

violence of aggressive warfare – that is, the invasion and occupation of another nation to accomplish someone's political objectives – I am happy to be able to tell you that I

have been able to find a personal peace; and part of that has come through my work as an advocate for truth and non-violence in my own life, in the life of my community, my nation, my world.

When it comes to war and peace, the principal issue we must deal with today in Canada is our nation's involvement in the war in Afghanistan.

It's kind of spooky, for I find the parallels with the Vietnam war to be quite remarkable -- perhaps the most notable exception being that Canada once had the moral and intellectual integrity to resist being bullied into invading and occupying a dirt-poor third-world nation half way around the world.

Afghanistan, like Vietnam, was invaded with the flimsiest of legal pretexts. And the unrestrained brute force in the

conduct of the war is responsible for the wholesale destruction of countless living and breathing human beings, war crimes, and destruction of much of the country.

Apparently the U.S. learned nothing from Vietnam or from Russia's previous invasion of Afghanistan. But perhaps even more sadly, Canadian officials also came up blank.

Thus our wonderful modern-day tradition of being an enlightened leader in the community of nations, through the pioneering of peacekeeping and effective hard-working diplomacy to resolve conflict, has been effectively squandered so our leaders can take us down the path of violence in a misguided belief it somehow increases our security.

This I know: they are wrong, for aggressive violence produces only more aggressive violence.

Sadly, we learn more in the headlines each day about violations of the Geneva conventions, the widespread scope and the truly horrific nature of the torture and abuse of countless detainees in Afghanistan and elsewhere – many of whom are thought to have been wrongly detained.

If you, like most Canadians, have been operating under the illusion that torture, torturing detainees to death, and other violations of international human rights laws have been limited to places like Abu Ghraib and Guantanamo Bay, prepare yourselves to be very upset. For new information is coming out every day that tells us that Bagram air base in Afghanistan is home of the new Guantanamo bay scandal – only worse – for it has long been hidden away out of the glare of public attention and been allowed to operate with total impunity.

Did you know that the disgusting degradation and torture we were shocked to see in the photos at Abu Ghraib only arrived there after it had been perfected as a matter of routine procedure by U.S. forces in Afghanistan? This was recently documented in the U.S. Senate Armed Services Committee inquiry into the treatment of detainees in U.S. custody, which was released December 11, 2008.

Did you know the abuses in Afghanistan were happening at a time when Canadian Forces were routinely and unquestioningly handing detainees over to U.S. forces – the sole detaining authority at the time? Handing detainees over to possible torture is a violation of the Geneva conventions. I first complained to the Canadian government years ago,

after known abuses were reported in the 2005 Report of the

independent expert, on the situation of human rights in Afghanistan, to the United Nations Commission on Human Rights; and I continue to complain – but these complaints have landed on deaf ears.

And how many Canadians are aware of the extent of the carnage and death being inflicted upon helpless civilians by NATO forces, which are primarily U.S., British and Canadian troops? President Harmid Karzai actually broke down and wept at one point, not too long ago, while speaking on Afghan national television about his inability to stop NATO forces from the continuing unrestrained slaughter of civilian women, children and men.

I can tell you without hesitation that Canadian Forces have violated the Geneva conventions right alongside their U.S. counterparts, but our government leaders won't acknowledge that. They want to cover it up and move on.

That just doesn't work for me, and I continue to document violations to Canadian authorities and make formal requests for a public investigation into violations.

I feel it is important to now insist that Canadian Forces be immediately removed from this horrible situation. It's a quagmire and no matter how much they try to redefine the purpose of the mission. I can tell you that the integrity of this mission for Canadian Forces has been lost and it is time to just say that.

There have been gross violations of the Geneva conventions, and Canada has full legal obligations to comply with the Geneva conventions.

I personally will never again have faith in the integrity of a Canadian Forces mission of any sort until something like a full-scale independent inquiry into what went wrong in Afghanistan is undertaken, followed by implementation of necessary procedures to make needed corrections.

And if we truly are interested in peace and security in our world today, we will also figure out a way to have Canadian Forces and all representatives of the Canadian government begin to work truthfully, in non-violent ways, to finding resolution of conflict in our world.

Three Potent Steps to a Sane Economy

Amidst today's uncertainties, is an historic opportunity to secure our lives and the lives of those we love. First we have to recognize the common cause of the financial and ecological crises - that human activity is touching planetary limits.

In order to achieve a balanced relationship with the Earth, we need to picture a new order in our hearts and in our minds.

Then, each time we buy food, pump gas or have a conversation with a friend, we can advance long-term well-being. Two different types of economic activity are identified below, followed by three potent steps we can take toward a sane economy. Together they provide a foundation for imagining what can be. As enough minds ripen the images, change happens. [Please pass these details around.]

Two types of economic activity:

"Economics" is a somewhat mysterious word for "mutual provision." While, individually, we have limited ability to provide for our needs, we produce abundance in societies. Each person gets good at certain tasks and we trade with each other. There are two types of economic activity. One type requires continual inputs of non-renewable resources and produces problematic waste. Transportation systems and disposable consumer goods are examples. The other type consists largely of human creativity and good-will, like education and most health care at the preventative level. While there are almost no physical limits to the amount of education and preventative care that we can have, there are serious limits associated with resource-intensive industries.

For the things that we do need from the resource-intensive line, the first two of the following steps can reduce our impacts on the Earth dramatically. All together, these three steps can usher in a long period of ecological stability. Three potent steps:

- 1) Shift the imagination and creativity that presently goes into designing for obsolescence and use it, instead, to design goods that are durable and easily repaired.
- 2) Instead of using our persuasive communication abilities to encourage people to throw things away and to buy new stuff, we could use those same talents to reclaim an appreciation for durable and familiar products.
- 3) Finally, if we search for personal fulfillment in what we can do with our lives, such as learning, love, laughter, friendship, art, music, dance, sport, service, and the like, rather than by accumulating and consuming material goods, we could have more real satisfaction while minimizing re-

source exploitation and waste.

While such steps would do wonders for securing the future, they would be disastrous for a growth-based economy. We either have to increase the size of the Earth, or reorganize mutual provision so that we can all share in the necessary work and revel in the new security.

There are many ways to reorganize mutual provision to serve a mature (post growth) civilization, but it is getting harder and harder to stretch the Earth. Do we want to grow until we drop, or develop the economics of sustainability? It is a Question of Direction.

Civilizations don't change direction easily. They must either suffer catastrophe, or exercise an extraordinary redirection of will. By launching a public discussion about which direction offers the better future, millions will come to imagine the options.

[April 13, 2006] When Antanas Mockus [the only son of a Lithuanian artist] became mayor of Bogotá, Colombia, in 1993, it looked like a job nobody in his right mind would want. Bogotá was corrupt, violent, and, in the opinion of many, ungovernable. But Mockus' approach to civic problems was not that of "normal" politicians. A mathematician and philosopher ... Mockus kicked off his administration with a series of outrageous stunts, like hiring 20 mimes to direct traffic and ... walking around Bogotá in a spandex bodysuit and a cape and calling himself "Supercitizen," and addressing TV viewers from his shower as part of a campaign to conserve water. But by the end of Mockus' two terms as mayor, it was clear that his unorthodox approach to government had worked. The homicide rate had fallen by 70 percent, traffic fatalities were down more than 50 percent, water use had dropped by 40 percent, and tax revenues had tripled, due in part to a program in which people voluntarily paid extra taxes.

For Doris Sommer, the Ira Jewell Williams Jr. Professor of Romance Languages and Literatures, Mockus' success not only proves that innovative strategies can produce good government, it is also a testimony to the power of art and the humanities to effect positive social change.

"Art has a capacity for unclogging stale systems. What Mockus did was to employ risk-taking creative ways out of dead ends. When you're an artist, you're never paralyzed."

Alzheimer's and Statin Drugs "Lipitor, Thief of Memory" – Book Review Roberta Histed, L'Orignal ON




A few weeks ago, on the CTV evening news, I heard a brief mention that Alzheimer's had reached epidemic proportion in North America and that health officials had no explanation for this. I then recalled reading a book review on Lipitor, Thief of Memory by Dr, Duane Graveline and decided to purchase the book to learn more.

Dr, Graveline is a former astronaut, aerospace medical research scientist, flight surgeon and family doctor. He talks about his own experiences with Lipitor as well as others that have been reported to him, and examines the science behind, and use of, anticholesterol drugs. I found his book very educational while being easy to read. I will here quote a couple of snippets:

With the experience of the past few years we have come to expect statin side effects such as liver damage, muscle pain, nerve damage and heart failure. Even the dreaded and formerly rare rhabdomyolysis – a condition that occurs when inflammation of the muscle cells is sufficiently severe to cause rupture of the muscle cells and potentially fatal blockage of the kidneys – has come to be expected from statins... But the everincreasing cognitive side effects from statins are new and completely unexpected by both patient and physician. ...thousands of cases of...extreme forgetfulness, disorientation and confusion have been reported to statin drug researchers. Most of these cases do not make it to the emergency rooms and are, undoubtedly, extensively under reported.

Dr. Graveline describes the way the body utilizes choles-



terol and why it is so vital to the healthy functioning of the human system. The brain cells, for example, depend on cholesterol to function. Although cholesterol is found in atherosclerotic plaques, he points out that it is not the active ingredient in them and that attacking cholesterol does not solve the problem. With his medical training, he believes he should have recognized sooner that there was a disconnect between the

hype about controlling cholesterol and the significant contributions of cholesterol to the body. But, he says:

...with both the American Medical Association and the American Heart Association actively promoting rigid cholesterol control, who was I to doubt?

He notes that, although cholesterol control has been diligently pursued for many years now, obesity has steadily increased. Also, although more heart patients are surviving now due to new surgical techniques, the incidence of heart disease has not diminished. It is time to abandon the received wisdom about cholesterol control and look to other sources to promote human health. Researchers are zeroing in on what trans fats, over-consumption of Omega 6 fats, oxidants, platelet malfunction and deficiency in CoQ10 are doing. There is also evidence that deficiency in certain B vitamins needs to be addressed.

The pharmaceutical companies have a strong vested interest in continuing to try to persuade us all that we need

to reduce our cholesterol using their products. After all, these anti-cholesterol drugs are raking in billions of dollars for them. The Swine Flu Swindle

On the B.C. Election

It Hurts, and Here's Why Rafe Mair, Vancouver BC In The Tyee.ca

The election was a big win for Gordon Campbell and the Liberals and, yes, it hurt and this column is a tad personal.

As spokesperson for **Save Our Rivers Society**, I travelled the entire province except the Peace River and I can't begin to count the speeches and other happenings. I obviously wasn't able to get out the message about private river energy and for that I must accept responsibility.

Last night (May 12th, election night) was a terrible one for the environment. Alex Morton, who has laboured so hard to save our salmon from the predation of fish farms must be bitterly disappointed, as am I.

I want to examine the election itself but I must touch upon the rivers matter for the record.

Private power generators will increase dramatically. The Bute Inlet project, larger in environmental impact than Site "C," will be approved shortly. When that happens, there will be no turning back. The message I tried to get out and failed in was getting people to understand that BC Hydro is compelled to buy that power at hugely inflated prices that it cannot come close to getting on the market. At present, Hydro has given out contracts amounting to \$31 BILLION dollars, rising with each new private power licence and, here's the rub, for energy we can't use because it comes with the spring run-off when BC Hydro has full reservoirs thus lots of power. The private power will go to the U.S. and the process, unless reversed, will spell the end of BC Hydro.

One of the critical points in the election was the Campbell government's steadfast refusal to debate this issue despite all the provocation I could provide. This is a sad commentary on the election process but was a very smart move by Campbell for our case is unanswerable. I suspect that Richard Neufeld's departure for the Senate was contrived as Premier Campbell knew his energy plan couldn't withstand even mild cross examination while the new minister knew nothing about the real issues and would be able to duck debate.

Victories for fish farms, river power giants
The big winners were Marine Harvest, the fish farm giant
and Warren Buffet, the largest shareholder of General Electric, partners with Plutonic Power Corporation Inc, the
promoters of the Bute Inlet project. The big losers were
those who care about fish and rivers.

In addition to refusing to debate the fish and power issues, Campbell skillfully painted himself as the steady hand on the tiller needed in these perilous economic times. He was able to do so because NDP leader Carole James could not avoid dealing with the NDP's traditional issues -- social issues -- thus blunting her attack on the economic front.

Campbell knew that his natural constituency did not, at this time at any rate, give a fiddler's wind passing for the homeless, the sick and the lame. His playing the economy card over and over again while refusing to get into other issues, except in a perfunctory way, had the effect of making Ms. James look like a bleeding heart while Campbell appeared as the white knight leading the province out of the economic wilderness.

Will fudged budget melt?

It's hard to criticize James because she obviously had to let her natural constituency know she was carrying their issues onto the battlefield. The end result was that Campbell had absolute control over the issue people wanted to hear about most -- the economy.

What comes next?

We'll see a new budget, which will remind many of the "fudget budget" of the Clark government in 1996, and we'll see a legislature more fractious than ever, which won't matter at all to Mr. Campbell who has, under our system, a four-year dictatorship ahead -- and none play the role of dictator better that he. We will have civil unrest over the rivers issue and when, not if, BC Hydro is broken up and sold. The polarization of our community will match if not exceed those days when Bill Bennett and Dave Barrett spat endless streams of venom at one another.

Finally, STV. What went wrong?

I can only relate to personal experiences. As a supporter of STV, I was asked to make a speech on its behalf, which I did -- it was before about 100 supporters in a room in the SFU downtown campus. Supporters! I was spending valuable time and energy for nothing!

The STV campaign was obviously taken over by the Bay Street crowd. The last thing British Columbians wanted were lectures from the likes of Andrew Coyne of the *Toronto Globe and Mail*.

I was asked to do an endorsement for the "yes" side and did so thinking it was for radio ads only to find out, to my horror, that I became part of a telemarketing exercise. I hate that stuff and so, my mail tells me, do a lot of people.

I feel desperately sorry for former MLA Nick Loenen who has put so many years on this project and can only speculate that if he had remained in control it might have turned out differently.

Bottom line? This issue is dead for a decade.

The election itself? History tells us that in bad times people often turn to the right. Yesterday was no exception.
