# Undoing of Canada begun by Mulroney in 1988

### The SPP reflects a surprising 23-year continuity of intent!

# -- a joint, right-wing Liberal/Conservative collusion since 1984 Russ Vinden, Errington BC a far greater degree of Cana



[EXTRACT] Contrary to expectations, another federal election has been postponed until next spring through some crafty footwork involving fixed election dates. The new Act, rushed through just before the summer recess, was hardly a cause for dismissing the government, so it has given the current government almost another year, free of

disruption, to complete its secretive negotiations for a major extension of NAFTA. Its warm, and fuzzy title is 'The Security and Prosperity Partnership', but it is more clearly expressed as 'The Greater North American Union.'

Spin, we are told, is everything, but the carefully selected title fairly shouts that vast and irreversible changes are afoot which we, the masses, will not like, and that obfuscation is necessary. Mr. Harper's political skills are not to be under-estimated.

However, it is a mistake for anyone to think that this major undertaking is only a New Conservative ambition (as in Mulroney / Alliance / Conservatism), for it was Liberal Paul Martin who happily announced completion of the first part of the negotiations, over four years ago. And it was his Liberal Deputy Prime Minister (John Manley) who calmly stated, after leaving his office three years ago, that "it was time for a major extension of NAFTA." Moreover, the large and rigorously screened meetings, which have taken place many times since then, have included top-level contingents from the Liberal hierarchy, Liberal ex-cabinet Ministers and their Deputies, as well as dozens of senior corporate executives, presidents, etc. (the prime financial supporters of both these Parties). These have been named and ably reported on in this magazine. There is no mistake, this is a joint, right-wing Liberal/Conservative policy, one of many - whatever their protestations of 'Party' differences.

It is my contention that we do not have two separate Parties on the right, but one, with cosmetics freely applied to hide what is a remarkably small power base in the corporate world. Unfortunately, resistance to their policies – divided between the New Democratic Party, the Canadian Action Party, and the Greens (I discount the Bloc) – enables those policies to be hammered into place, by merely taking advantage of a situation which certainly would not exist under a fair voting system.

I simply do not believe that a majority of electors in this country wish to see relations with our US neighbours further codified in the inevitably one-sided deals so far constructed, like the FTA and NAFTA. Rather, they desire that

a far greater degree of Canadian sovereignty to be proclaimed and upheld, and the massive American intrusion into our economy and influence on our culture and social arrangements curtailed, but this desire gets little expression in the mainstream media in the country, owned by a tiny handful of corporations.

The current negotiations were set in place by the Liberal Party hierarchy, not in response to overwhelming requests from their own local branches, or even initiatives from their national conferences following lengthy debate. They were seamlessly adopted by the Conservatives under the same non-democratic limitations. Clearly, they represent top-down legislation, driven by a large, permanent big- business lobby, well funded at taxpayers' expense; and they expose the fundamental faults of our decaying Parliamentary system.

This is now driven by the vastly increased power of an unelected Prime Minister's Office, and constrained by a rigid insistence on conformity by government MPs. Protests about independent views being expressed in caucus carry little weight when respected MPs of long standing are summarily dismissed by their Leader for daring to remind him of his neglected election promises. The message is not missed by his colleagues – criticise and you're out, gone, your Parliamentary career terminated, and the electors who put you there dismissed as a tiresome irrelevance.

This situation is not good. Our hands are tied by a dismally ineffective electoral system, and it is obvious that the Lib/Con collusion will keep it that way. While its short-comings have received steady publicity over the years, there has never been the slightest sign of any real intention by either Party to change it. Despite a general reduction in voter turnout, the system has maintained either Libs or Cons alternating in power for well over a century, and effectively kept the Left-leaning Parties out of power, even though they collect, in total, far more votes.

Vocal in Opposition, Libs and Cons follow their predecessor's major policies in lock-step when elected. Each follows the other in total acceptance of major policies (their protests in Opposition swiftly forgotten): whether it be the Stone Age voting system; total privatisation of government debt; acceptance of the associated GST and other high taxes (which necessarily follow the debt); massive cutbacks to programs, all of which resulted directly from the construction of immense debts; and even the absolute about-face, immediately after the 1984 election, which set the FTA rolling, and then NAFTA and now the SPP – reflecting a surprising 23-year continuity of intent!

Below is a letter I recently wrote to Prime Minister Harper in which I refer to the Security and Prosperity Partnership of North America (SPP). Earlier, I left a copy of the Council of Canadians' in depth article about SPP entitled, "Behind Closed Doors" at your board office for each of you.

Letter to the Prime Minister

#### Prime Minister Harper:

I am a senior-senior Canadian. The Canada I have grown up in has been a wonderful country, a truly great example of what a country should be for its citizens and for the world of nations. Sadly, things have changed to the detriment of our citizens and our world neighbours. # North American Integration and the Militarization of the Arctic

[AUG. 20 07, EXTRACT] The Battle for the Arctic is part of a global military agenda of conquest and territorial control. It has been described as a New Cold War between Russia and America.


Washington's objective is to secure territorial control, on behalf of the Anglo-American oil giants, over extensive Arctic oil and natural gas reserves. The Arctic region could hold up to 25% of the World's oil and gas reserves, according to some estimates. (Moscow Times, 3 August 2007). These estimates are corroborated by the U.S. Geological Survey (USGS): "The real possibility exists that you could have another world class petroleum province like the North Sea." (quoted by CNNMoney.com, 25 October 2006)

From Washington's perspective, the battle for the Arctic is part of broader global military agenda.

It is intimately related to the process of North American integration under the Security and Prosperity Partnership Agreement (SPP) and the proposed North American Union (NAU). The SPP envisages, under the auspices of a proposed "multiservice [North American] Defense Command", the militarization of a vast territory extending from the Caribbean basin to the Canadian Arctic.

It also bears a relationship to America's hegemonic objectives in different parts of the World including the Middle East. The underlying economic objective of US military operations is the conquest, privatization and appropriation of the World's reserves of fossil fuel. The Arctic is no exception. The Arctic is an integral part of the "Battle for Oil". It is one of the remaining frontiers of untapped energy reserves.

The Arctic nations (with territories North of the Arctic circle) are Russia, Canada, Denmark, the US, Norway, Sweden, Finland and Iceland. The first three countries (Russia,



Canada and Denmark) possess significant territories extending northwards of the Arctic circle. (see Map). [...]
Canada's Arctic Military Facilities

Ottawa's July 2007 decision to establish a military facility in Resolute Bay in the Northwest Passage was not intended to reassert "Canadian sovereignty. In fact quite the opposite. It was established in consultation with Washington. A deep-water port at Nanisivik, on the northern tip of Baffin Island is also envisaged.


The US administration is firmly behind the Canadian government's decision. The latter does not "reassert Canadian sovereignty". Quite the opposite. It is a means to eventually establish US territorial control over Canada's entire Arctic region including its waterways.

Under the renegotiated North American Aerospace Defense Agreement (NORAD), the US military has access to Canada's domestic territorial waters including Canada's sea shelf with the Arctic, which coincidentally also provides Washington under the guise of "North American sovereignty" with a justification to challenge Russia in the Arctic. ## BOOK REVIEW

"Banker to the Poor"

Review of Muhammad Yunus' book, "Banker to the Poor." by J Makhan Dubé, Nanaimo BC

[EXTRACT] We have become accustomed to the notion that the affluent Northern Industrial countries have the physical and

intellectual resources to solve all global problems. This notion has been widely disseminated in the voluminous reports by experts in our consultancy industry, by the news media and, latterly, by the great entertainment figures e.g. Bob Geldorf and Bono on Woodstock-like platforms, adorning philanthropic giants like Bill Gates, George Soros and others.

There is no gainsaying that good things can be achieved by these initiatives, and that more is being achieved as more experience is gained in the exercise of their programmes. One unfortunate side effect of these Northern strategies is that the poorer recipient countries of the South are considered as passive objects of charity without any ability to assess their own situation realistically, or to formulate effective solutions based on more sensitive knowledge, culled from their own experience.


The task of alleviating the massive problem of poverty in the Southern countries for instance has been appropriated by the giant financial institutions of the North for the last fifty years, with questionable results. In his book "Banker to the Poor", Muhammad Yunus, a Bangladeshi citizen describes his experiences as he takes on the challenge to address the endemic poverty around him and, against all odds, rescued hundreds of thousands of his fellow citizens. He has been consulted by such financial stalwarts as the head of the World Bank.

After some thirty years of operating a Grameen (village) bank, he has won the Nobel prize (2006) for peace. His example has inspired the micro-credit movement world-wide, benefiting millions of needy and disadvantaged ignored entrepreneurs around the world.

Born in the 1940's, as the historic struggle to throw off colonialism was being waged, Mohammed Yunus grew up in what would become Bangladesh, a part of Pakistan, eventually an independent country. His was a devout Muslim family in small business. In 1965, he was awarded a Fullbright scholarship and studied at the University of Colorado (Boulder campus) where he obtained his Ph.D. in Economics.

He became caught up in the Bengali League of America, a group of concerned professionals in the USA when Pakistan invaded what was then East Pakistan, later to become independent Bangladesh.

On returning to Bangladesh in 1972, he was employed by the Planning Department of the Government, then became Head of the Economics Department of Chittagong Univer-



favour of hands-on, person-to-person experience.

In-depth study of the poor in Jobra revealed that the village women made beautifully hand-woven bamboo stools. A bamboo trader provided the bamboo and received the finished stool, leaving her with 2 cents per day for herself. This was just enough to keep her alive and in perpetual bondage. To borrow money to buy the bamboo herself meant dealing with moneylenders who charged 10% per week or per day. Money lenders do good business lending for such things as seeds, sowing, fertilisers, pesticides and such ingrained cultural practices as dowries and extravagant weddings. Often, new loans would have to be taken out to pay off old loans. Eventually he considered lending a needy person 22 cents. But on second thought, he did not think that this would make the significant contribution that he had in mind. What was needed was an institutional answer that those people could rely on. They had no collateral. In other words, only the rich could access the recognised banks.

Due to some good fortune and long-standing connections, he did get a loan for \$300 but had to sign as a guarantor for each individual loan when the money was given out. More than 98% of the loans were repaid. Support groups were required to approve each loan request and assume the moral responsibility for the loan. A rural bank was opened to circumvent sharia law, which forbids interest payment. There was a 7-day training course for prospective members and testing of individuals. [...] Muhammad Yunus is training micro-credit officers from many countries, and gaining more recognition for it from financial foundations through a Global Grameen Trust. He laments the fact that most economists have failed to understand the social power of credit. He considers credit a human right, and claims that banks have imposed a financial apartheid against the poor as unworthy of credit.

But he is aware that there are other complementary factors in the eradication of poverty. I quote: "Micro-credit is not a miracle cure that can eliminate poverty in one fell swoop. But it can end poverty for many and reduce its severity for others. Combined with other innovative programs that unleash people's potential, micro-credit is an essential tool in our search for a poverty-free world."



## "Stirring the Soup"

#### It takes all kinds

It takes all kinds to make a world, so they say. That's actually very true on many levels. Human resource professionals are constantly struggling to find the right "fit" for employees in their organizations. The type of person you'd find working in the Wellness field would be vastly different from

the type you'd find working in a Collections office (or so you'd think). Even within the Collections office itself, the various employees would have to be dissimilar to some degree in order to work cohesively.

In relationships, too, you'll note that the couple is two quite different people. One will likely be an introvert and the other an extrovert. One will be thrifty and the other will like to spend (with the woman not always being the latter). One will be a neat-freak and the other a slob. One can balance a check-book and the other is inept with financial matters. Not surprising there are challenges – but put these two together to work towards a common goal (Costa Rica for their next vacation) and they make an unbeatable team! When each brings his or her own special set of skills to the table, wondrous things can happen! This doesn't mean that their differences disappear -- she still thinks he should do more around the house and he still considers her a worldclass nag – but they can be put aside while the focus is on something important to both of them. If you watch such a collaborative effort closely, it's a thing of beauty.

I witnessed such an event in Edmonton on August 25, 2007. I had been informed of a conference being held at the Chin Yin Buddhist Temple (an architectural delight for those of us accustomed to our bland North American structures). The **Interfaith End of Life Care** workshop promised to be very interesting, especially for health workers, family members and friends of terminally ill patients. Admission was free, as were the refreshments and the complimentary luncheon. The ever-smiling Buddhists hosted representatives from the Church of Jesus Christ of Latter-Day Saints, Baptist/Pentecostal/Full Gospel pastors, Sikhs, Jains, Hindus, First Nations elders, as well as representatives from the Baha'i, Muslim, Jewish, Zoroastrian, Unitarian, Eckankar, Scientology and Church of Religious Science faiths. Can you picture it? An entire roomful of people with religious beliefs ranging from one end of the spectrum to the other – and all under one roof!

What in the world would bring these people together? Because, even in a multi-cultural country such as Canada, this

was a big surprise to me. Well, they simply found a common goal. They realized that if we are to share this big, beautiful country, there will be times when we will need each other. One such time will be at our passing from this life to the next. Nearly everyone who was in attendance at this workshop (but not all) believes in an afterlife. And although everyone's views of that afterlife differed, all present were committed to offering to their fellow Canadians the best possible end-of-life care, respectful of the person's belief system. Collectively, they organized this conference and assembled in one place to openly share their most vulnerable identity to a packed house of people from all ethnic backgrounds and walks of life. That's the kind of courage you don't see every day. I personally don't think I would ever stand up in front of a large number of people and announce my spiritual beliefs. But who knows – if there was a good enough reason...

These people had a good reason. After all, when the time comes for any of us to go, how do we know where we'll be and who will be with us? We of course (and our families) would wish for us to be around someone who has at least an inkling of what we believe is about to happen to us. Otherwise, wouldn't we just be perplexed when a Hindu, in all good conscience, would lay us down on the ground (to be closer to Mother Earth, according to his belief system). If we were near a Sikh, would we feel comforted or frustrated by his assertion that "life never ends" as we lay dying (there is just a short transition from one plane to the next, in his opinion). Would we wonder, as we breathed our last next to a First Nations person, why she was blowing smoke into our non-smoking face (smudging, to help guide our spirit to the afterlife). Would our Buddhist friends help or hinder our passing by telling us that we may be reincarnated next as an animal (one of the 6 realms of existence we can be born to during our countless lifetimes). We would of course feel much more at ease if, in our final minutes, we were accorded a nice peaceful (insert end-oflife ritual of choice here). But there's no guarantee that will be available, is there?

The participants of the End-of-life-Care Conference are now closer than most to having their beliefs honoured and observed on their deathbed. And they are more prepared than most to assist a fellow human being to pass over in the most peaceful and humane manner possible, no matter what their position on life after death.

Some time after this conference, I had lunch with a friend and was telling her about what I had learned there. She seemed to think that the whole multi-cultural phenomenon in Canada just wasn't going to work. She felt that other cul-

A year ago he shared your poem, "Just a Common Soldier," with my family and me. This poem truly affected him because he lived through the experience of war. However, what surprised me was how much I was affected by it. Today we have fighting overseas in Iraq, and up until I read your poem, I tried not to think much of it. War is something that affects us all but also puts a question on the real meaning of life and existence.

Behind the wars, there are hundreds of thousands of individual people with their own lives, their own families, and their own hopes and dreams, I never looked at it from that perspective until I read your poem. It's truly a tragedy that so many people have died because of war. However, the bigger tragedy is that no one has seemed to learn a lesson and we still continue to add to this pointless loss of life.

My grandfather could apply the meaning of your poem to his experiences of war and all the friends he may have lost and lives he's seen ruined. I think he could understand and relate to what you wrote the most because he experienced it first hand. When he was sent to fight, he had his own life and family. But because the people we have given the most influence in the world can't agree for one reason or another,

What surprised me was that this poem not only affected my grandfather, but me as well. Times have changed since he was younger, but war is still in the world. To be honest, politics and government have never been a topic that interested me. I've always felt I had more important things to worry about in my life and that I shouldn't obsess over things like that. The fighting overseas was always just something that was happening that would get sorted out eventually. Then a few years ago I heard the idea of a draft was being thrown around. All I remember was being much younger and not really understanding the idea. I feared my parents would have to go and fight and I would lose them forever. I now know that they are too old to be drafted, but it was a scary idea to have as a child. It just shows how war affects everyone, even those not involved.

Now that I am older, and still getting older, I realize that war could start to affect me. It seems the fighting has been going on for a while and things don't seem to be getting better. The future is getting more and more unpredictable and it's become apparent that a future draft is a possibility.

This really makes me question the meaning of life and existence. Ten years of school, countless nights of homework, working hard for a good future, what's the point of it all? If there's a chance of being sent off to the war, then were all these years of work wasted? Why are we here if we're just going to destroy each other? — All questions I found myself asking when I thought about the issues presented in your poem. I've heard the term "world peace" used a lot, but I've just thought of it as something extreme activists wished for. I never thought much into what it actually meant. However, now I understand that it really would solve a lot of problems.

I never liked the idea of war and fighting, but all my life I had thought of my grandfather as a hero. Then I realized – how could I support someone fighting for a cause I don't support? After thinking about your poem, I decided it was possible to feel this way. The common soldiers who fought for our safety are the true heroes. They gave up their lives, their families, their hopes and dreams, just because their country told them to. Fighting may not be the best solution, but they worked to make it so the future wouldn't have to deal with the tragedy they had to go through. I am not the kind of person who would ever take part in a war, but I truly respect the soldiers whose self sacrifice was a step towards a safer and more peaceful future.

- 1) Costs of Federal Bilingualism in Canada
- 2) Costs of Provincial and Local Government Bilingualism in Canada
- 3) Optimal Language Policy for Canada

The Fraser Institute is seeking financial support for this work, as each of these studies would cost approximately \$90,000, and they will not go ahead until they are fully funded.

Since circulating the information on the above proposed study by the Fraser Institute, I have received a number of positive responses from people who are very happy that finally, we've been able to get a prestigious organization to turn its attention to a topic that is avoided by all politicians and most members of mainstream media. #### Faith-based schools

Another very contentious topic is the proposed Tory funding of (more) faith-based schools. The debate is centered around the idea that this encourages segregation by having faith-based schools. In order of the above, funding per student based on total revenue: #1 gets \$8,773; #2 gets \$9,117; #3 gets \$10,460. Expenditures per student: #1 spends \$9,374; #2 spends \$8,726; #3 spends \$11,469. Conclusion: French education costs more: why? Why are the public schools not making a fuss about this? Why do they accept this inequity so silently? [...] \*
