#### Euthanasia - a naïve approach By Peter Goldring, MP, Edmonton East AB

A Bloc Quebecois MP's Private Members' Bill, C-384, on the right to die with dignity, is frighteningly naïve, and should not be supported.

The proposed legislation would amend the Criminal Code to allow a medical practitioner to aid a person who is experiencing severe physical or mental pain, or is suffering from a terminal illness, to die with dignity once the person has given his or her consent to die.

It sounds noble: ending pain and suffering and supposedly giving the right of a person to decide themselves to die with dignity. The reality is, once society starts deciding who is to live and who is to die, compassionate reasons can readily be replaced with criminal greed. Such poorly defined euthanasia legislation (how do you define mental pain?) is an assault on the elderly, sick and infirm who have entrusted decision making to others for their compassionate care. In fact the bill will make the elderly even more of a target by the greedy, impatient opportunists, some of whom are their very own children.

Shamefully, elder abuse, physical, mental and financial is a rapidly growing concern in Canada. Were this legislation to pass, it is not difficult to imagine the death of elderly Canadians who otherwise would have no desire for premature death – but whose close family members made the decision to encourage an early inheritance.

Many elderly people, on medications or not, have difficulty deciding on issues, have times of depression and are susceptible to being influenced by others. This poorly worded

legislation does not take into account the subtle and not so subtle abusive coercion that could cause a proud senior to ask for euthanasia as an escape from the abuse, rather than face the shame of reporting close family members' abuses. I think C-384 is an evil piece of legislation that must be defeated. We need better, stronger laws to protect the elderly, not laws that put the elderly at greater risk. I will be voting to defeat this bill and I encourage others to do so too. \*

In common with Lewis Lapham, former editor of Harper's who now publishes <u>Lapham's Quarterly</u>, I have a deep suspicion of great conspiracy theories.

# Canadian Court will review Government decision to bar British MP George Galloway from Canada

George Galloway wins leave for judicial review

November 2, 2009 (Toronto) - British MP George Galloway scored an important legal victory on October 30 when the Federal Court of Canada agreed to hear a judicial review of the government decision to ban his entry from Canada. On March 20, 2009, the office of Minister of Citizenship and Immigration Jason Kenney announced that Galloway would not be allowed to enter Canada, just days before his arrival for a four-city speaking tour.

Galloway had been invited by the Toronto Coalition to Stop the War and other Canadian peace organizations to speak in Toronto, Mississauga, Montreal and Ottawa in March and April 2009 about his humanitarian aid convoy to Gaza and his opposition to the war in Afghanistan. The government ban kept Galloway out of Canada.

"I am delighted by the decision of the Federal Court of Canada," said Mr. Galloway. "Jason Kenney may oppose my views, but he has no right to prevent Canadians themselves from hearing what I have to say. I look forward to challenging in court Mr. Kenney's attack on free speech." The case is expected to be heard in Federal Court in January 2010.

**George Galloway** has been a Member of Parliament in the British House of Commons since 1987, and currently represents Bethnal Green and Bow in London for the Respect Party.

The **Toronto Coalition to Stop the War** is Toronto's leading peace coalition; represents over 70 labour, student, faith and community groups; and is a member of the Canadian Peace Alliance.

# Legality of legislation no longer a priority for governments? Gerry Masuda, Duncan BC

When I worked in Ottawa, I learned that, at that time, all draft bills were sent to the Dept. of Justice or the Attorney General's office to be checked to ensure that the draft did not contravene any current regulation.

Each draft was then circulated among all departments and agencies, with the instruction to determine the impact it would have on that dept/agency.

It appears that this very practical practice is no longer being followed. In BC, the Campbell government has passed legislation, which, even to the average citizen, appears to contravene some basic laws/rights. This is a political action taken knowing that it would take years and a great deal of money to challenge these laws in the courts.

## CODEX requires antibiotics, growth stimulants & irradiation

Brief comments on the article that follows:

#### From Chris Bowers, Gabriola:

Hi Folks, This does not look to me as if either the SPP or the negative impacts of Codex have been dealt with at all.

#### From Stephanie McDowall:

We are betrayed. CODEX requires antibiotics, growth stimulants & irradiation of our food. As stupid or ridiculous as this may sound, this looks to me like a deliberate attempt to shorten people's life spans. What do the NDP say now regarding all their assurances that this Codex had been dealt with when we were expressing concern re Bill C-6? This calls for a revolt of some kind but what?

Reports: [with Referenced links at the end of this article] Canada will be harmonized via the Trans-Tasman Agreement. Penalties for non-compliance via trade mechanisms of WTO. [1] Codex requires that all conventionally farmed livestock must be treated with antibiotics, veterinary drugs, hormones, and growth stimulants. No exceptions...

Veterinary drugs are permitted without limit or penalty even if overused regardless of how harmful they may be ...

#### 9 - ORGANIC FOODS

... The standards and definitions of "organic food" will be changed. Under Codex, a farmer or rancher will be able to call his products "organic" when they are full of toxic poisons. The Codex definition of "organic food" includes as little as 70% organic contents but without saying that on the label. (The other 30% can consist of poisons or contaminants.)

Organic, free range and biodynamic farming (both crops and livestock), while technically permitted, are defined so loosely that antibiotics, toxins like Rotenone, fish and dairy products for livestock feed, and veterinary drugs (including antimicrobials) may be used at the discretion of the certifying agent or farmer...

Both plants and animals can be given poisons of various kinds only a little time before harvesting, milking, or butchering. Farmers need only switch to "organic," nochemical methods just before harvesting. Ranchers can move livestock to "organic" fields just prior to going to market.

#### 10 - IRRADIATION OF FOOD [1]

Codex Alimentarius fully legalizes and requires irradiation of food at the time of harvesting or butchering. Yet irradiation is widely opposed by food safety advocates... Codex has weakened the international food irradiation rule, by allowing any food to be irradiated at any dose, regardless of how high it may be. The new standard lists no maximum radiation dose...The decision to do this was made by the chairman of Codex, over the objections of more than 10 countries (including Austria, Denmark, Germany, Italy, Mexico, and Spain)...

The irradiation of food produces immense, free-radical populations in that food. The higher the ionizing dose, the higher the free-radical production. Under Codex, food components may be irradiated and then, as they are combined with other components, they may be irradiated again. And again, and again!

Each time, the free-radical population is increased. The only protection against their pervasive damage is high doses of anti-oxidants like Vitamin C, beta carotene, glutathione, etc., which would be illegal under Codex.

#### Letter to the Minister of Finance From Erik Andersen, Gabriola Island BC

During your recent appearance before the Standing Committee on Finance you suggested that the economic and financial reversals of 2008 came as a surprise to you

and presumably your Department and fellow Cabinet Ministers. It almost sounded as if you were "blind sided". Maybe that is an indicator that you are using the wrong people. For example, Brooksley Born, Chair of the Commodities Futures Trading Commission from 1996 to 1999 made it very apparent that the derivatives market was out of control and as a consequence, in a very dangerous condition. Of course the rogues of Wall Street would not let her spoil their party so they hounded her out of office. Those doing the hounding were Chairman Greenspan, Mr. Rubin and Mr. Sommers.

Six weeks after her resignation the US authorities were trying to save the global financial system brought on by the collapse of Long Term Capital Management. Numerous lessons were there to be learned by those who you are now taking advice from. Another example from the many I could site is a chart dated July 2007 titled "Phase 2 of the Great Credit Crunch: ABX Mortgage Indexes". This chart depicted a 50% crash in values over a six month period (I have enclosed the chart).

You may also remember my many expressions of concern about the investment practices at the CPP Fund. Despite several assurances from yourself and former Minister Goodale I remain anxious. Let me illustrate the reason for this concern by showing you examples of the handiwork of the CPP IB.

First off is the takeover of Macquarie Communication Group. I know you already have the half year financial statements for the period ending December 31, 2008 so there is no further need to point out the loss position and the enormous debt load at the company. What I have included is a commentary written by Stephen Bartholomeusz and published in the "Business Spectator" on June 16, 2009. Please note the words "despite being priced at a massive premium to MCIG's pre-offer trading". The pre-offer trading stock price was about 80 cents; the first offering price by the CPP IB was at \$2.50; the subsequent post "green mail" price was at \$3.00. That translates into a takeover premium paid by the beneficiaries of the CPP Fund of about \$ 1.5 billion.

Second example is the takeover of Livingston International Income Fund. This time I am enclosing some of the financial statements dated June 30, 2009. This stock traded at a pre-offer price of about \$5. The CPP IB offer of \$8 means the takeover premium of about \$100 million.

Third example is IMS Health Inc. Based upon the preliminary information the takeover premium appears to be at almost 100% over the pre-offer price for the stock (I have  $\Rightarrow$  enclosed some financial statements from a recent filing). This recent investment record by the CPP IB shows a pattern of overpaying for investments at a time when corporate de-levering still has a long way to go. In my opinion this demonstrates why the design of the investment strategy used by the CPP IB is wrong and why CPP Fund beneficiaries have reason to be anxious.

Please intervene by prohibiting new equity investments until a review of the general investment strategy can be conducted.

# Using the Bank of Canada to carry public debt! Richard Priestman (COMER), Kingston ON lation mainly by lends

An NDP federal candidate asked for a statement to explain how the Bank of Canada could be used. Here is the reply. The concept is very simple. If you owned a bakery, why would you buy bread at a higher price from someone else? (Don Rogers at a COMER meeting in Kingston, 18/10/09) The government owns a bank, the Bank of Canada, which can create money (credit) the same way that commercial banks do. When a bank makes a loan it enters the amount of the loan (credit) in the borrower's account. Before the entry is made, that credit did not exist. After the entry is made the borrower can write cheques on the account and withdraw cash. The same applies when the government of Canada borrows from the Bank of Canada (the Bank). Some people find it hard to believe how simple the process of creating credit/money is. As John Kenneth Galbraith (a well known Canadian-American economist) said, "The

Some people find it hard to believe how simple the process of creating credit/money is. As John Kenneth Galbraith (a well known Canadian-American economist) said, "The process by which money is created is so simple that the mind is repelled." It seems that it should be more complicated for something so important, but it is not. Banks have created credit on their books for hundreds of years – and charged interest on the easily created credit.

When the government borrows from the Bank of Canada, any interest paid to the Bank is returned as dividend minus a tiny amount for administration. It's a virtually interest-free loan. So why does the government of Canada borrow from the private sector and pay interest instead of borrowing from its own bank? Besides the cost of the interest, borrowing privately leaves the government vulnerable to the demands of its creditors. Mackenzie King, Canada's longest sitting prime minister, understood the danger in this and stated in the 1935 election campaign:

"Once a nation parts with the control of its currency and credit, it matters not who makes that nation's laws. Usury, once in control, will wreck any nation. Until the control of the issue of currency and credit is restored to government and recognized as its most conspicuous and sacred responsibility, all talk of the sovereignty of Parliament and of democracy is idle and futile."

After the election he proceeded to nationalize the Bank of Canada, which had been established in 1934 as a private corporation, completing the process by 1938. For the next 35 years the Bank controlled the amount of money in circu-

lation mainly by lending to the government significant amounts of new money as needed while at the same time controlling the amount of money created by the commercial banks through the statutory reserve system. It also encouraged commercial banks to keep their interest rates low. During this period we had the best economic times ever and inflation never got out of control.

For years the banking industry lobbied for looser regulations. After 1974 the government began borrowing more from the private sector while reducing its use of the statutory reserve system and its use of the Bank of Canada to carry public debt. As a result, control over the issue of credit was lost. Then, when interest rates went sky high in the early 1980's so too did the federal debt, increasing over 3000% from \$18-billion in 1974 to \$588-billion in 1997. (Statutory reserves in Canada were completely abolished by Prime Minister Brian Mulroney in 1991-92.)

Total debt owing from all levels of government rose to over \$900-billion. While it was reduced for a time by the federal government's surpluses it will climb again due to the deficits being incurred. The interest being paid is huge. The cost in 2008, which of course is out of date, was \$62.3-billion. That figure is so big it is meaningless without being compared to something else. For example, it is 623 times bigger than the \$100-million sponsorship scandal and amounts to more than \$170-million per day. The cost of interest is reflected in the price of everything we buy.

So why does the government of Canada borrow from the private sector and pay interest instead of borrowing from its own bank interest free? As far as I can see it is because of the influence of those who control money. The government is in debt up to its eyeballs. It is afraid to do anything which might result in higher interest rates so it bows down to the money interests. It slashes existing programs such as health care and education, refuses to bring in day care services or adequately support infrastructure improvements. To regain control over the issue of credit requires politicians who will talk openly about the situation and promote use of the Bank of Canada to carry public debt as well as reinstatement of the statutory reserves. Until this happens we will continue to be controlled by those who control money.

## Who are the real Olympic disrupters?

Much has been made in the mainstream media (i.e., the large scale commercial media) about the "disgraceful" disruption of the opening of the 2010 Olympic torch relay by a motley collage of anarchist low life "professional protesters". Calls for jail sentences bounced around the pages

of Canwestglobal like so many ping pong balls gone wild. Reporters were unable to refrain from seizing the anticipated rhetorical high ground to condemn how the same nihilist rabble crushed the dreams of a 17-year old torch bearer with cerebral palsy and cruelly disappointed small children happily waiting for their heroes to triumphantly run past. Not least, the potty-mouthed demonstrators used the f-bomb to shock Victorian grandmothers and toddlers alike... and heavens, even did so more than once!

Does this perfidy ever end? No, it appears not, since the same Goths and Vandals were willing to kill police horses with the surreptitious placement of marbles on the streets, thus endangering both the beasts and their masters.

In the aftermath of Victoria, one provincial Liberal party MLA was moved enough by the potential mayhem to use the word "terrorist" to describe the perpetrators of the al-

leged outrage. Lions and tigers and bears (and anarchists), oh my!

Where, or where, to start dismantling this wheelbarrow of horse manure? We can begin with the marbles since

this got a significant portion of the

media scrutiny. Did it happen? Yes. Who did it? **No one knows.** But we do know this: It was the protesters on the scene who were picking the marbles up, some of whom may have been on the receiving end of a horse-borne riot squad charge, not one of the most pleasant experiences in the world. I saw one such charge, up close and personal, in Seattle 10 years ago and had to dodge down an alley with my nine-year-old son to keep from being run over. Not fun. Next, yes, the f-word was said – repeatedly – but one has to assume the good burghers of Victoria, young and old alike, had heard it before. The kid with the disorder who couldn't run? He ran the next day in Nanaimo; hence, no permanent psychic scars.

Finally, what on earth is a 'professional' protester and how would one know one? Where does their illusory funding come from now that the Soviet Union is gone (or even before for that matter)? Can there really, truly be anyone out there who believes that there exist protesters who go from

city to city just to demonstrate as some sort of lunatic day job? The idea is just outright dumb... and rapidly heading for dumber. (But there is a caveat to this, as I will show below).

Clearly some people will believe anything. After all, 64% of those voting in the 2003 Vancouver Olympic plebiscite believed the late Jack Poole in his wildly imaginative assertion that hosting the 2010 Games would make money for the city and province. Scroll forward to last week's Price, Waterhouse, Coopers report on the economic impact of the 2010 Games to see just how badly informed that subpopulation of Vancouverites actually were.

As the above suggests, much of the media hype was not only juvenile, it also managed to miss the main point: The true disrupters were not those out on the streets in Victoria protesting the torch, rather those who brought the Circus' torch to town in the first place.

Think about it: The torch – originally a Nazi symbol for the 1936 Olympic Games – ran through much of downtown Victoria on a work day, closing streets left and right, interfering with people going to work or getting their kids to school, and blocking deliveries (and customers) for businesses. And all for what? So that the Olympic circus would have a happy send off as it made its way out of town to disrupt people across the country. I wonder if anyone has cal-

culated the lost wages and productivity of a 106 day relay of disruption.

**Or how about this:** During the period from mid January to the end of March 2010, that is between the beginning of the transportation/security street closures

in Vancouver to the end of the Paralympics, all of the above —and more- will occur solely to enable those who want the unfettered "**right to party**" to celebrate the Games.

Vast areas of downtown Vancouver will be closed to any traffic at all; other routes will have "Olympic lanes" dedicated to the "Olympic family", athletes, and the omnipresent security forces. What we will get with our party is a **two month-long fun zone of absolute gridlock** for those just trying to go about their daily lives. Do you own a small business that can't afford a two-month closure at all, let alone during a recession? Are you a salaried worker near a closed area and can't afford to take vacation and fly away to warmer climes? Do you need to get your children to school or the doctor?

For all of you, tough beans, the Circus is coming to town and your only response is to party. Or maybe you can just sulk quietly at home; God forbid you should go out and protest.

So what's the difference between the disruptions...

So what's the difference between the disruptions caused by Olympic protesters and those caused by the Olympics?

**How about this:** One kind of disruption is sanctioned – even welcomed – by the government, the other not; one is designed to contest the utter infringement on our collective rights, the other to celebrate an event that has tried to put those same rights in the garbage; one creates a few hours of messy street democracy; the other creates two months of lost revenues and missed opportunities.

The real disrupters are the masters of the Olympic circus itself

The real disrupters, the ones who do get paid to travel around the globe messing with peoples' lives, are not those out on the streets trying to reclaim a small piece of the commons for the rest of us, but rather the masters of the Olympic circus itself. If you want to put Olympic disrupters in jail, start with the real criminals.

# Chris Shaw sues City over civil rights

I was planning to spend Vancouver's long Olympic Winter hiding under a rock.

Indeed, I didn't see the point of picking a hopeless fight against the mighty Olympics. How does one even start doing that? So I resigned myself. Calendar cleared, TV unplugged, mind set to zen, heavy books stockpiled: I was ready to kill some Olympic time.

My plans have been upset. The BC Government and Vancouver City Council have turned over my rock. The brats. Against my will and my better judgment, they have thrown me back into service as an anti-Olympic activist.

Among other things, the bylaw orders that, under penalty of heavy fines and prison time (yes I know: what?!), there will be:

a. no signs on a stick

- b. no blocking of someone's view with that sign
- c. no voice amplification device
- d. no interfering with another person's enjoyment of the pro-Games celebrations (whatever that is supposed to mean)
- e. no material that does not celebrate the Games

Obviously, this has ceased to be about the Olympic games. Whether you are a personal fan of the 5 rings or not, you've got to hate this bylaw. The blow that this legislation strikes to our most basic civil liberties is mind expanding.

So much for the image of Vancouver's City Council as being a progressive bunch. The cat is out of the bag. Vision Vancouver has obamized itself. It has sold out to the transnational corporate agenda and neoliberal shock doctrine, like so many other leftists before them.

As I ponder the number of true progressives sitting on this Council (some of which I know personally and whose good intentions I can vouch for), I measure the massive pressure that they have been submitted to, as they approached the iron core of the corporate planet. Nobody, left or right, can resist such crushing forces.

While I am sitting across the restaurant table from Chris Shaw, I realize the relevance of his legal action and the supreme intelligence of it. If he wins, Bill 13 is killed in its tracks, the Charter of Rights is strengthened as it builds precedent against such laws in the future. Incidentally, for your information, my latest figure for "This Huge Cost", to March 31, 2008, is \$1.15 trillion, increasing at the rate of something in excess of \$19 billion, per year.

These two figures are my estimates for total costs: Federal, plus Provincial, plus Private Sector.

Others, who have attempted to estimate these costs, to my knowledge, are: Scott Reid, MP, Canadian Taxpayer Federation, and The Fraser Institute. In all three cases their estimates for federal costs only, are higher than my own federal costs, and in the case of The Fraser Institute, substantially so. What would happen to their figures, if provincial and private sector costs are added to theirs for total costs!

Bearing in mind that private sector costs have been estimated to be about 20 X government costs, if the factors I used for provincial costs are reasonable and applied, all three would produce total costs higher than mine, and The Fraser Institute's astronomically so! ...

Yes! Canadians should indeed feel 'both languages belong to them'. But they don't! Not even close!

The system, especially this **Official Languages Act**, is contributing to making it so. French-speaking Canadians, through distortions of our history, feel they have been short changed by the English-speaking Canadians; and the English-speaking Canadians feel, especially due to this Official Languages Act, that French-speaking Canadians (less than 25% of Canadians) now control Canada, thus subverting our former democracy.

Canadians indeed do not have a sense of ownership of both official languages. Not surprisingly, bilinguals (17% of Canadians), with their vested control of the country, do have such a sense, federally, but they are only 17% of the population! Provincially, Quebec is officially unilingual French, New Brunswick is officially bilingual, Ontario (why?) is creeping towards unofficial bilingualism, and the Rest of Canada, is mainly unilingual English.

For the large majority, the other language is anything but "inherent" (in born) in what Canada is about! On the contrary! It is a curse!

The other language does not distinguish us from other countries. Other countries, such as Switzerland and Belgium, for example, also have "other" languages.

The other language is not (quoting the Commissioner) "as central an identifier for a Canadian event as the Canadian flag" because, for one reason, the Canadian flag is conspicuously not flown in most of the province of Quebec! And nor is the other language as much an identifier as "the metric system", because feet and inches, for example, are still used, unofficially, in Canada, and, of course, in our biggest and very influential trading partner, the US.

Canada cannot celebrate four decades of official bilingualism by laughing. At an estimated cost of over \$1 trillion for the 40 years since its inception, with hardly any increase in bilingual ability and much more pressing needs neglected through lack of funds, weeping would be more accurate. Please see my INFORMATION RELEASED BY STATISTICS CANADA IN DECEMBER 2007, attached. If you need further confirming evidence, please advise.

The still needed work required 40 years later mentioned above, is simply – to call a nation-wide referendum on the subject, and if the majority is opposed to the Act, repeal the "nightmare"! – Jim Allan \*

# "The Fifth Columnist"

#### 2b or not 2b?

Picture a young William Shatner with the dramatic mail box slit of light across his eyes, reading these lines:

"Everyone has the following fundamental freedoms: ... thought, belief, opinion and expression, including freedom of the press and other means of communication."

These lofty words are from Canada's Constitution Act, 1982. Okay, with this picture in your mind, ask yourself when "everyone" isn't really everyone.

Now I know that talking about the Constitution is guaranteed to put most Canadians to sleep, but it's time to wake up! There's been a tacit agreement in Ottawa that since Anglos are in the majority in Canada, even though they are a minority in Quebec, they're not REALLY a minority and therefore can be discriminated against with French Canada's hateful, paranoid language laws.

It was former Prime Minister Paul Martin, at the beginning of the same-sex marriage debate, who said that you can't cherry-pick rights, meaning that you can't pick the rights you happen to agree with. There was some irony in this statement, because Martin, whose power base was in Quebec, consistently failed to defend the rights of minority English speakers violated by Law 101, a 30-year old crime against humanity that persists to this day.

During this very same debate, Martin actually praised the Liberal's support for Official Bilingualism. What is the purpose of Quebec's Law 101 and Canada's Official Bilingualism, the happy face Ottawa sticks on the Official Languages Act and a number of offensive, discriminatory hiring policies? Both impose the French language, on other groups. Law 101 imposes the French language on non-French speaking minority groups in Quebec. Official Bilingualism imposes the French language on the majority outside of Quebec.

It was only a matter of time before French Canada's paranoia over "assimilation" was enacted outside of Quebec. In Eastern Ontario it has already begun. The mayor of the Township of Russell, one Ken Hill, a unilingual English speaker, took it upon himself to make Russell officially bilingual by mandating bilingual signage for businesses in Russell.

Howard Galganov, a human rights crusader (hailing from Montreal, now living in Eastern Ontario), has legally served the mayor of Russell, charging that the mayor and his morally-impaired councillors have violated the constitutional rights, specifically section 2b, of business owners, a class of people who apparently have no rights. Basically,

the town mayor has imposed a culture and a language on another class of people. This was a terrible crime when Canada did it to the natives, and for which, by the way, Canada has apologized, and yet for English speakers in Quebec and now business owners and their employees in Russell, you must do as you're told.

Galganov asks this simple question: "Does the supposed right of any cultural group, regardless of their size and standing in Canada, have the right to abrogate Section 2b of the Canadian Charter of Rights and Freedoms for the purpose of promoting and/or protecting their culture at the expense of others who pose no wilful threat to that culture?" Section 2b is very clear and states unequivocally that EVE-RYONE (every individual) has these rights. To be told that your signs must be bilingual or face heavy fines means that your government is telling you what language to speak. It's not just about the signs! After all, if you put out a bilingual sign, you are saying you speak both languages! If you are unilingual, you obviously have to hire a bilingual person. In effect, the state is telling you who to hire or not hire and how to communicate with others. The state is saying that they have the right, not you, in determining how you will communicate and express yourself in the conduct of your business, because of your political class.

While section 15.(1) of our charter says that "Every individual is equal before the law and has the right to equal protection and equal benefit of the law with discrimination..." the problem, my friends, is another section of this "constitution", section 15, subsection 2, which states (cue Bill Shatner), "Subsection (1) does not preclude any <u>law</u>, program or activity that has as its object the amelioration of conditions of disadvantaged individuals or <u>groups</u> (my italics) including those that are disadvantaged because of race, national or ethnic origin, colour, religion, sex, age, or mental or physical disability."

So, even though discrimination by individuals is loathsome, it is *okay* for the Canadian government to discriminate to "right" a "wrong". The minority just has to claim its victim status to Canada, and Canada will gleefully strip individuals of their fundamental human rights to make it "right". Do the words in section 2b mean anything at all? Or is our constitution a fraud? Howard Galganov may end up taking his case to the Supreme Court. On this great day, Canadians will finally see whether these lofty words really apply to "everyone".

Do we live in a Potemkin village, a Liberal façade and a fraud, a case of 2b or not 2b? That is the question.

Neither of them ever mentioned anything about only receiving "a pencil and an orange" in their Christmas stocking, but I've heard others tell that story often enough over the years that I know Christmas was a bit different back then. Of course as the annual orgy of holiday spending seems to grow exponentially each year, telling today's kids that for my generation the biggest Christmas decision was whether to ask Santa for Hot Wheels or a GI Joe with Kung Fu grip probably sounds rather quaint.

When I was a kid it always felt like Christmas couldn't come soon enough. The annual ritual of selecting a tree, participating in the Christmas pageant, carolling; it was my favourite time of the entire year. The arrival of Santa at our local mall was always a memorable experience, because for some reason our Santa eschewed the traditional sleigh in favour of flying in by helicopter, which I always found odd. I suppose it could have been stranger – I have since seen him arrive, over the years, by parachute and surfboard. Growing up in Quebec added an additional element to the Santa paradox, because I never quite understood why Santa always spoke with a heavy French accent. Of course no kid is going to worry about such inconsistencies very long when the guy's handing out candy canes.

Each year the decorating of our home was a major undertaking. The job of stringing the lights on our tree always fell to the older members of our family. At some point far back, and for a reason I cannot remember, I began the annual custom of lying underneath our tree and looking up through the branches. The mixture of the wonderful evergreen fragrance and twinkling colours was intoxicating;

I wanted to live in that magical world completely surrounded by branches, tinsel and decorations.

Back then Christmas lights glowed at a temperature that could actually burn your fingers. And our lights didn't flash on and off in a long string; oh no, they twinkled, each one separately – some even bubbled. Today's new LED versions just don't seem to provide the same experience, although they no doubt create less of a fire hazard.

Each Christmas I try to do one thing that will make the holiday memorable; something that I can look back on and say, "That was the Christmas of..." For many years while growing up I read Dickens' "A Christmas Carol" every December. As a teenager I dressed up in a Santa suit and visited younger kids in my neighbourhood. In my 20's I recorded a selection of Christmas songs.

Then in 1993 I was hired to compose the score for a huge Christmas stage extravaganza in Toronto. I recall sitting in the theatre's balcony with my brother, waiting to enjoy a matinee, when the entire orchestra suddenly walked out because their paycheques hadn't arrived. Somehow the wonder of Christmas was a little less evident to me that day, even less so the next day when we had to sneak back into the theatre and rescue my sheet music from the orchestra pit. Memorable does not always equal good.

This year I will be enjoying Toronto's wonderful Santa Claus parade from the comfort of a second story window in a 19th century mansion along the parade route, then watching a Christmas pageant complete with live camels and donkeys. Quite a distance from the farmhouses of my parents' youth.

Each year my father gave the same toast at Christmas dinner; he was thankful that we were all able to celebrate one more holiday together. He was blessed to enjoy 85 Christmases, all of them (with the exception of his time overseas during the war) with family. In over two decades he only ever missed writing his Christmas column for these pages once, when I filled in for him.

As we all raise a glass and toast Christmas this year, I'll be taking the opportunity to reflect on the past 12 months. Hopefully I've lived them well but just to be sure I'm doing it right, from now on I vow to measure my life not in birthdays, but in Christmases.

#### **ABOUT HOLISM**

Dialogue seems to have an increasingly interesting medical section. Since authors are free to provide their own opinions, it is mandatory to write from evidence on this subject. This is required by any medical journal where statements must be either referenced or supported from observation. I would like, therefore, to call into question some of the statements

made in "Looking at Health from a Holistic Perspective" (*Dialogue Oct-Nov 2009*).

First, I must say that I totally agree with the emergence and slow development of so-called holistic medicine. It is the medicine of Hippocrates. Edison, however brilliant he was, was a latecomer and so are we modern practitioners. It has excellent scientific backing but in order to integrate with or replace the present medical system it requires a lot more research and development.

To say that autism is a "systemic body-wide problem that affects the brain" is undoubtedly true but may be "putting the cart before the horse". It is just as true to say that it is a sick brain that affects the body. Depression and other emotional representation is a function of the limbic system, the part of the brain that computes input data for organizing adaptive reactions to environmental influences and deals with our emotional reactions. Depression is a normal biochemical reaction to the stimuli that trigger it. It is only when this reaction is fired without the appropriate stimulus that it becomes abnormal. It is not, strictly speaking, a thought process. Neither can it be ignored as an important brain response.

The evidence is that the automatic part of the brain "talks" to the body and the body, through a complex of messengers, "talks" to itself and "talks back" to the brain. It is a three way street. For example, we now have evidence that for every signal that goes to the bowel, there are 9 signals that go from the bowel to the brain. The best analogy that we have for an organism as complex as homo sapiens is the computer. The dominant opinion is that the body does the bidding of the computer in the skull, not the other way round. It is absolutely true that physical stimuli to the body affect brain function, but to deny that brain function affects the body is a reduction to absurdity.

Holistic medicine (the term is derived from an ancient language where holos was a hill from the side of which the people gathered herbs) is not a modern "breakthrough" at all. Its history is long and tenuous. Modern pharmaceutical therapy is the "newcomer" and its development resulted from the relatively narrow basis that came from the work of

Pasteur. But even he admitted that the body defenses were more important that the attack of the microorganisms.

The point that I want to make, as I have said many times in these pages, is that the body defenses require a "command post" and the evidence is strongly in favor of that being in the head. We know that brain tissue has the highest requirement for oxygen and if it dies, the body dies with it. This surely suggests that the brain is working very hard to maintain all the required adaptive processes required for bodily survival.

We should remember the mythology of Ondine, a water nymph who was jilted by her human lover. Ondine cursed him with the loss of all automatic functions and he had to remain awake to control them. He became tired and fell asleep. Hence he "forgot to breathe" and died in his sleep. This story has recurred through the ages and suggests that it was an explanation for sudden death observed from time to time that defied explanation. Mythology has always been the invention of people in explaining phenomena that defy rational explanation.

There is a well recognized disease known as "Ondine's Curse" where the automatic computer functions of the brainstem fail for biochemical reasons and death follows. The patient usually dies during sleep, something that is familiar to many as Sudden Infant Death Syndrome. Oxygen is the primary nutrient and its deficiency affects every cell in the body, as everyone knows. Oxygen has no value whatsoever unless it is consumed. That requires protein, fat and carbohydrate as fuel and a huge series of vitamins and minerals to "ignite the fuel". Failure of oxidative metabolism is a common cause of disease and it is not too hard to guess that the maximum rate of consumption is in the brain. Mental or physical work requires more cellular energy to meet the stress demand and it does not need to be emphasized that mental work is more tiring than physical work, although the body may not be functioning very hard at the time. Hans Selye spent his professional life studying the effect of stress in animals. As a medical student, he recognized that all the patients that were introduced to the students had the same facial expression, irrespective of the nature of the disease. That is why he decided to study stress as the defining mechanism of this characteristic facial expression. We all know that the fight-or-flight reflex is caused by a massive stimulation of the sympathetic nervous system, a system designed for short-term action and ultimate survival. It demands a huge consumption of energy by both the body and the brain.

Selve's experiments were cruel to the thousands of rats that

he sacrificed and the work must be extrapolated to human

disease. He developed the General Adaptation Syndrome,

an extraordinarily complicated analysis that has

unfortunately been largely forgotten. It is very clear that he was studying a brain/body function and he concluded that human diseases were the "diseases of adaptation".

I have read his work over and over, because the biochemical changes that he recorded are highly relevant to what we see daily in the laboratory studies seen in patients. This is precisely why the nature of the "fuel" is so vital to our normal physiology. It enables us to provide the energy required to meet the stresses of life and I do not need to emphasize how great that is in the modern world. I believe that Selye was dead right in his emphasis on the mental compo-

nents of our adaptive strategies. Today I see even young people who feel cold when they should feel hot and vice versa. Their "physical" symptoms are obvious functions of maladaptive sensory input that engender chaotic maladaptive body responses mediated through the central control mechanisms of the automatic brain. The brain is indeed the "command post" of the body fortress.

# Dr. Lonsdale's comment regarding "Murder in the Medicine Cabinet" [an extract of which follows, with link (below)]

There is much truth in this article. Fever is indeed part of the body's defensive process, though it does not apply uniquely to virus replication. Attacking microorganisms have their maximum effect at normal body temperature, 37 degrees C/98.6F. The "thermostat" lodged in the automatic centers of the brain, recognizes the "attack" and causes the rise in body temperature to render the biology of the microorganism less efficient. It has always been a mystery to me why doctors used antipyretics, of which aspirin is certainly the best known. ## Supreme Court schools-ruling backs PQ leader's claim

Canada is 'another nation' in Quebec, says Pauline Marois

MONTREAL - Ironically, the Supreme Court of Canada's latest attempt to balance fundamental rights with Quebec nationalism's opposition to them has served only to bring confederation's credibility into question once again.

And before dismissing Parti Quebecois leader Pauline Marois's disdain for the October 22 decision as so much separatist rhetoric, you might want to re-assess your anger over her summation of the SCC as being a court "appointed by another nation." You just might be a victim of your own misplaced anger.

That's because it has become almost impossible, even for die-hard federalists in Quebec, to pretend that the cumulative effect of so many court rulings and federal policies since the 1970s hasn't led to de facto Quebec separation -where Canadians foot the bill for a province whose people really don't live here anymore.

In Quebec, Canada is indeed "another nation" because its language-law values, among others, don't apply

here. That's the obvious conclusion after the SCC appeasingly ruled against Quebec's Bill 104, a sister-law to Bill 101 that was created in 2002 to suppress parents' right to choose the language of their children's education.

Briefly, the court said Bill 104 violates the Canadian Charter of Rights and Freedoms – but granted Quebec one full year to find a way around it, to dress it up, so that access to English schools will become impossible for all francophones, anglophones and immigrants who don't meet Bill 101's strict admissions

criteria. The relatively few children helped by the court's recent ruling will also be shut out, and presently remain in a state of legal suspended animation.

Christine St. Pierre, Minister of Culture in Premier Jean Charest's Liberal government, said she was "shocked and disappointed" by the court ruling – and not because it failed to assert Canadian charter rights unequivocally here. Predictably, the PQ is calling upon Charest to override the SCC ruling by invoking the Canadian constitution's "notwithstanding" clause to preclude endless court battles.

Earlier, parents of kids ineligible for English schools – by Quebec's definition – hoped to gain access by paying tuition at unsubsidized English schools, staying enrolled long enough to attain the necessary amount of time such that they could meet the government's requirement that the "major part" of one's schooling be in English, then transfer to an English public school.

Through Bill 104, Quebec tried to block this path by disqualifying time spent in these unsubsidized "transition" English schools that aren't covered by Bill 101 – a step the SCC called "overly drastic," though it stated that Quebec's overall goal was justifiable.

The SCC also condemned the transition-school practice: "When schools are established primarily to bring about the transfer of ineligible students to the publicly-funded English-language system, and the instruction they give in fact serves that end, it cannot be said that the resulting educational pathway is genuine." Further, "The short period of attendance at a minority language school is not indicative of a genuine commitment and cannot on its own be enough for a child's parent to obtain the status of a rights holder under the Canadian Charter," it said.

Non-genuine educational pathways, indications of genuine commitment to God-knows-what, even teaching in English to ensure eligibility under the discriminatory Bill 101 – hey, whatever happened to real Canadian rights and freedoms? And values like equality before the law?

You know, rights and values that weren't about doubletalk, self-serving legalese and walking silly semantic tight-

ropes to appease that gang in Quebec? Whatever happened to that other nation – the one that was worth defending simply because it defended

**Lawyer Brent Tyler...** was the driving force behind the Bill 104 fight in the Supreme Court, and deserves supreme thanks from Canadians who believe in equality before the law. Unlike his counterparts on the Quebec and Canadian governments' side, Tyler isn't getting rich from his ongoing and thankless efforts.

Canada's top court will always act to extend Frenchlanguage rights and privileges in Canada. Yet in 2002, it refused even to hear a case brought by Tyler involving forbidden English on signs in Quebec. (Ironically, the Quebec Court that first heard this case decided against the Quebec government sign law – and the judge, Danielle Cote, was a Parti Québecois appointee.)

As Tyler said then, "What the Supreme Court is telling the Canadian people is that you can be a Canadian citizen living in Quebec, have Canada's official languages on your sign and be prosecuted for doing so."

(The SCC also refused to hear a case brought by many English Quebecers opposed to the Parti Québecois government's plan to amalgamate their cities and towns in greater Montreal with the cash-strapped City of Montreal. Fearing many of their communities would lose their bilingual status, the plaintiffs sought protection as an official-language minority community.)

Arguing the schools-access case in Quebec Superior Court in 2000, Tyler landed a judicial knockout-punch, arguing Quebec has signed many international treaties upholding childrens' rights, yet bans francophone and immigrant kids from attending English schools based solely on who their parents are.

That is, Quebec's language law also violates the province's own rights charter because it removes benefits, rights or privileges based on a factual characteristic – that of a parent's being a francophone.

Canada's a signatory to many such treaties, including the UN's Recommendations Against Discrimination in Education, and is thus in violation of them because it permits such clear discrimination within its national borders, Tyler said earlier.

Just like Canada, Quebec continues to promote itself through noble-sounding pretense on the world stage, while doing the exact opposite in its domestic policy. Just like South Africa and its former practice of apartheid, Quebec

assigns civil rights based on who your parents are – effectively, based on blood-lines. And Canada approves.

**The Suburban**... is Quebec's second-largest English-language newspaper. On the Bill 104 ruling, it said the Supreme Court compromised not only freedom of choice, "it compromised its own integrity...by delaying the executability of its own judgement for a year in order to give the Quebec government time to find a palatable method of breaching those self-same rights," politicizing itself "to the point of self-abnegation."

The SCC unanimously recognized an injustice, and unanimously allowed the injustice to continue, a decision "driven by political expediency. It sought to uphold principle and pander to power at the same time.

"If the SCC can prejudice a right through legal machinations, how much less legitimate is it for [violent Quebec nationalists] to prejudice that right – as well as that of free expression – through physical menace? It is only a question of degree. It is the Court itself that has cheapened Canadian conscience and constitutional consequence and left the door open for thugs."

The year delay it gave Quebec "sustained the general Quebec objective of social and political marginalization of minorities and the language rights that adhere to them." It thus failed in its Charter duty to protect minorities. "The Court did not act justly."

## Decision finds police at Montebello incited violence

OTTAWA, Oct. 22 /CNW Telbec/ - More than two years after they posed as protestors at a demonstration against the North American Leaders' Summit in Montebello, three Quebec police officers were found to have "failed to respect the authority of the law by inciting persons to violence."

The ruling by the "Comité à la déontologie policière"\*, released yesterday, also found that the officers were disrespectful or impolite, used obscene, blasphemous or abusive language, and refused to produce identification when asked.

"This is a victory for democracy and for the democratic right to peaceful protests, but I have the same question I had two years ago," says Dave Coles, the man who unmasked the protestors.

"Who ordered them to do it? We need an independent judicial inquiry into the whole cover-up. When people show up to protest because they are concerned about an issue - and they are attacked by those who are supposed to be defending them... there is something wrong with the system."

Mr. Coles, President of the Communications, Energy and Paperworkers Union, made news headlines, when his attempts to stop three burly men, dressed in black, one armed with a rock, from infiltrating the peaceful protest, were caught on video and posted on YouTube. He called for a public inquiry immediately following the Aug. 20, 2007 incident.

"These officers did not make the decision on their own to pose as demonstrators and incite violence. Police were used to try to turn a peaceful protest into a violent one. The public should be very concerned."

The three police officers must now appear before the committee investigating their behaviour within the next two weeks.

# SFU Profs Slam Campbell's Energy Plan

Hobbling BC Hydro so private firms can profit big is bad public policy.

Two Simon Fraser University professors, both experts in power issues, have written scathing critiques of the Campbell government's energy policy.

First, they affirm the argument I've been making for over a year -- that BC Hydro is being forced to buy private power at up to double its market value, sell it at a huge loss, and then, assuming that this idiotic government tubes Burrard Thermal as our backup power, it has buy back that power at high import prices!

Here's how Professor Douglas McArthur confirms that opinion on his blog **PolicyCentre.ca**:

"Private hydro produces most of its power in the spring and summer when B.C. already has a surplus of power from BC Hydro's already established plants. It doesn't need more power in the spring and summer when the runoff is high. But the government is making BC Hydro buy the power from these producers at inflated prices, even though

it will have to turn around and sell it into export markets at much lower spring and summer market prices. Then, in the winter, BC Hydro will have to buy very expensive power from producers in the U.S. The private hydro producers will make a lot of money, Hydro will lose huge amounts of money on the whole complicated deal, and BC Hydro customers will make up the difference in higher rates... [The] government explanations just don't add up when subjected to scrutiny. If this was happening in India or Pakistan we would be raising no end of questions." [...]

In a nutshell, then, Campbell forces BC Hydro to buy all the private power produced on a "take or pay basis" at up to twice its value at a time when its not needed, meaning Hydro must sell it at half price into the export market and buy it back at much, much higher prices if they do need power. How do they get away with it? [...]

# The Gordon Campbell Government of BC: A "Criminal Gang"? Robin Mathews, Victoria BC flashes like the light that flashes off diamonds making them

If the title of this piece seems an adventure in humour – then it must be Black Humour. For the condition of government in British Columbia is almost beyond belief in its massing of wealth for private interests, its stripping of support for social uses and programs, its hell-bent awarding of dubious contracts, its digging the province into a debt load of surrealist size, and its almost unopposed anaesthetizing of police forces, press and media, and political Opposition. To add to that, the province has a premier who is (always in a whisper) alleged to have elevated his mistress to a position of enormous power and to a salary that would make the heads of ordinary British Columbians spin in dizziness. A Central American dictatorship? No. The Province of British Columbia.

We think of 'criminal gangs' as unruly adolescents massing at street corners or (one step up) operating brutal organizations to traffic drugs or stolen commodities. We rarely take the concept further to include the rotten administrations that suck the blood from their societies in what are called often 'Banana Republics'. Those are places where the ruling group enriches its friends as primary activity, has the support of the police, and is portrayed in its own press and media as colourful, eccentric, occasionally wayward – but the only sensible option for those who want a government which can "manage the people's affairs responsibly".

Those are places – like B.C. – where the political Opposition is a decoration, almost never hitting the most egregious sins, but forever glancing off critical issues in

appear more attractive. Those are places where members of the political Opposition (a) seem to make the a profession of getting elected (not of opposing), (b) have lost all ideology and so are incapable of presenting platforms with any meaning (c) are 'managed' by apolitical appointees who hug teaspoonsful of power (d) and – most importantly – swell and bulge to fill every opposition space so that the development of real opposition is a huge and daunting task. In British Columbia, the shadowy spending and backroom contracting for the 2010 Winter Olympics is paralleled by proposals to outlaw opposition signage anywhere within a wide radius of the games - to outlaw, that is, Freedom of Expression. Vancouver Sun columnist Ian Mulgrew writes of "the draconian Olympic sign bylaws". Conversation about that proposal is almost conducted in normal voices! And just below the border, a warehouse full of U.S. 'experts' is helping to design the incredibly costly "security" apparatus to assure "terrorists" won't use the ten days or so of Olympiad to 'destabilize' B.C.'s law-abiding community (or to spill over into Obama Paradise with demonlike intentions). As the costs of those madnesses unfolds

Does anyone really pretend that will be about top-level athletics? The nature of Olympic contracts that will drag

British Columbians through trenches of debt for decades go almost unexamined, except by individuals trying to shout through the smoke and mirrors. The same may be said about "expansionist" contracts that parallel "the games". To my knowledge, one lady is attempting to track the almost lunatic structure in "Sea to Sky Highway" contracts that reek of cronyism and gigantic expenditures programmed into the far future. Laila Yuile is also trying to unpick Fraser Valley bridge contracts, expenses, networks. To my knowledge, she is doing it almost alone while the "protective" institutions of the province: media, police, political Opposition, focus attention almost anywhere else (as if by carefully scripted design).

**Tearing apart any semblance of fiduciary duty** – that is, responsibility to meet the promises to and the reasonable expectations of the electorate – the Gordon Campbell group has castrated, shredded, and privatized (partially in secret) BC Hydro – formerly a major dollar getter for provincial expenditures. I believe there is strong possibility of serious malfeasance involved. [Malfeasance: official misconduct; violation of a public trust or duty.]

The Gordon Campbell group is alienating the revenue gathering power of ALL B.C. rivers and passing it to private (often U.S.) interests. The action over decades will involve billions of dollars of lost government revenue and escalating energy costs to all British Columbians. Power to direct and control the exploitation of water energy will reside outside Canada. I believe there is strong possibility of serious malfeasance involved in the changes to BC Hydro and the new "rivers policy".

BC Ferries, a spectacular dive into fake private corporate ownership in which flagrant debt is held completely by taxpayers, has a U.S.-imported CEO who recently was reported to be making a million dollars a year. Routes are trimmed. Carrying is down. Fares climb. Competence and morale sink. Bonus structures for the elect are "fantasy'. Created early in his premiership, BC Ferries is 'a Gordon Campbell special'. The gigantic spending in having new ships built offshore seems nowhere to be recorded as part of the public debt.

Then there is the BC Rail Scandal – the transfer of

BC Rail, a key economic, community lifeline and dollar-getter for provincial revenues, to the now-Texashead-quartered CN Rail. BC Rail was the brilliant possession of the people of B.C., with a far-stretching future of use, in almost every way, to the security and well-being of British Columbians. It was not only shabbily and stupidly alienated. I believe it was done so with serious – as yet untabbed – malfeasance.

I have written to the top RCMP officer in British Columbia, Gary Bass, asking for full RCMP investigation — on a brilliantly prepared basis. Deputy Commissioner Bass appears to be hiding (perhaps in Gordon Campbell's basement?). He will not so much as acknowledge my detailed request to him. His refusal even to acknowledge my letter, I insist — if it continues — is, in itself, a declaration of incompetence or of a wilful refusal of duty.

"On a brilliantly prepared basis" I write of the condition for investigation of what I believe is major malfeasance in the transfer of BC Rail to CN. How so?

Out of the so-called "sale" of BC Rail – its transfer to the private corporate ownership of CN Rail – came a strange **set of charges** against three top cabinet aides (in the employ of Gordon Campbell who placed them in ministries). They – it is alleged – engaged (variously) in 14 counts of fraud, breach of trust, and money laundering. And they did so, allegedly, in specific relation to the "sale" of BC Rail, leaking confidential government information, accepting favours in reward, etcetera. How the men were chosen for 'charges', and how the specific charges were worked out becomes more and more difficult for an ordinary Canadian to comprehend. And that is because of new information that floods in on the matter with every "application" by the Defence counsel for evidentiary material necessary to the defence of the accused men. The new information appears to implicate, in improper behaviour, major actors in the transfer, up to and including Gordon Campbell, premier of the province. [...] [Read in full in the print edition]

#### The Global Land Grab

ROME: Last year's elephant in the room at the FAO's World Summit on Food Security was the outrageous profits corporate agribusiness were amassing during the peak of the global food crisis, while over a billion people went hungry. This year it is the global farmland grab. Investors are colluding with governments to take control of tens of millions of hectares of prime farmland in Asia, Africa and Latin America. Governments pushing these deals, such as Saudi Arabia or South Korea, see outsourced food production as a new strategy to feed their own people without relying on international trade. Private investors see agricultural land in emerging economies as a new source of guaranteed returns in light of ongoing high food prices.

Either way, this farmland grab is turning the food crisis into an opportunity for even more profits as the expansion of export-oriented agribusiness is at the heart of it. More than \$100 billion is on the table, and over 40 million hectares have already been acquired from Ethiopia to Indonesia. Small scale farmers are losing critical access to land and water, and local communities will be further cut off from access to food. Yet they are usually kept completely in the dark about these deals, without any involvement in the decisions that affect lands they have cultivated for generations. The implications for the global food system are dramatic.

For farmers organisations and social movements converging in Rome, this global land grab is unacceptable. It has nothing to do with strengthening family farming and local markets, which in our view is the only way forward to achieve food systems that actually feed people. It must be stopped. The "win-win" land grab scenarios that will be proposed to governments at the official FAO Summit are dangerous and unrealistic. Of course we need investment. But investment in food sovereignty, in a million local markets and in the four billion rural people who currently produce most of the food that our societies rely on -- not in a few mega-farms controlled by a few mega-landlords. From 13-17 Nov. 09, representatives from peasant organisations and social movements that have been directly involved in struggles against this new wave of global land grabbing will be in Rome. NGOs and activist groups that have conducted extensive research and analysis of the issue will also be present. This is an excellent opportunity for media to speak with people directly involved in this fight.

### WHERE IS THE JUSTICE FOR THE PALESTINIANS?

"I am Anna Baltzer."

My first reaction when I heard these things by the way was complete disbelief. I thought there is no way, there is no way that Israel is anything different from what I believe it to be, and what I know it to be. When I met people who told me anything different, I thought well these are perfectly nice people, but they have been brain washed. They have been told propaganda. And I set out to sort of try and prove them wrong. To show them that I knew what I was talking about. And as soon as I began to do some research, I realized very quickly that I was the one who is missing a lot of information on this issue. And not knowing sort of who to believe anymore, decided to go there and see with my own two eyes what was happening in Palestine.

So what I travel around the country, telling people about, is what I found there. I hope I can offer people a combination of sort of some of the basics of what's going on there, and then also some ways of going a little bit deeper into the history, and most importantly, where we can go from here. I like to start out by clarifying a few different categories that can be very confusing to people in addressing this issue. I'd like to distinguish between what it means to be Jewish: so I am Jewish what does that mean. Somebody who is Jewish is somebody either of the Jewish religion, obviously, or the Jewish lineage. My mother is Jewish, her mother is Jewish, etceteras. It's a bloodline.

And that to be Jewish is different from what it means to be Israeli: an Israeli is a citizenship, and Israeli is a citizen of the state of Israel. And that to be Israeli is different from what it means to be a Zionist: Zionism is the political ideology that supports the idea of a Jewish state in historic Palestine, sometimes no matter what that means in reality, and no matter what it does.

Anyway, these are different categories, Jewish, Israeli, Zionist. And sometimes they overlap in the same person, but they are not the same thing. There are Jews who are not Israeli, like myself. There are Israelis who aren't Jewish, about 20 percent of the Israeli population is Palestinian.

There are Jews who are anti-Zionist, who say this land should be for anybody who's been living there for generations regardless of what their religion or their ethnicity is. And then there are Zionists who aren't Jewish. The increasingly influential Christian Zionist movement, largely based in this country that talks about fueling this conflict to bring about the Armageddon, the return of the Messiah. Again, not at all pro-Jewish, right? You know what happens to Jews in the Armageddon is not about preserving Judeism, it is Zionism. So we see this distinction and it's very important that we see that distinction and that we express it when we are talking about this issue. First of all, because there is no reason to associate anything that Israel is doing in terms of occupation, oppression, segregation, things that were pretty sobering that I found when I was over there. These things have nothing to do with Judeism.

And likewise, to speak out when we see people's rights being violated is not anti-Jewish. It's not anti-Semitic. In fact, it's in line with the tradition of social justice that has been the pride of Jewish people, as well as many other communities, for a very long time. So I want to start out with that, especially because I know that people talking about this issue are often, sort of, these names are called at you, and it's absolutely absurd. There is nothing Jewish about what Israel's doing, nothing anti-Jewish about speaking out when we see it happening.'
