### Concerns about Bill C-51

### Reducing drug approval safety

Council of Canadians: May 22 08 - As recently noted by the National Union of Public and General Employees (NUPGE), "The Harper government has introduced Bill C-51, an Act to amend the Food and Drugs Act, which dramatically reduces safety requirements for drug approval. The current system of drug approval requires prior evidence of a minimum of safety and efficacy. However, C-51 reverses existing process by bringing 'promising' new drugs onto the market and then monitoring their effectiveness. This practice will expose Canadians to new drugs before their potential dangers are known. C-51 would permit the speedy marketing of expensive new drugs — many of which have no therapeutic advantage over safer, cheaper drugs — before research on effectiveness and safety is completed."

They add, "Even post-marketing 'surveillance' to be done after new drugs are marketed will be carried out by the drug manufacturer involved, and thus will be biased in favour of the product being reviewed. For patients with rare diseases, who require access to groundbreaking new medications and can't wait for a long approval process, a special access program already exists, one that does not include a general

lowering of standards." [...] The Harper government's Bill C-51 would introduce the 'progressive licensing' of new pharmaceutical products in Canada. Progressive licensing means an increased reliance on research conducted by the drug manufacturers themselves, fast-tracking the drug approval process, and the appraisal of the safety of drugs once they are on the market, again primarily by the drug companies themselves.

[...] Additionally, the CBC recently reported that, "Critics feel the bill will outlaw up to 60 per cent of natural health products currently sold in Canada, making many natural health products that have been sold in Canada for decades unavailable for purchase and penalizing parents who give herbs or supplements to their children. They also argue that the government could designate any natural health product a prescription drug, making it available by prescription only. On April 8th, 2008, The Canadian Minister of Health introduced Bill C-51 into the House of Commons. This bill proposes significant changes to the current Food and Drug Act, that will affect most Canadians. They intend to bypass elected officials and vote in bureaucratic laws from other countries, without our consent. They intend to remove 60% of Natural Health Products presently available, in our health stores, and make them available, only by prescription. More than 70% of the people in Canada use Natural Health Products. The new Enforced Powers intend to allow Inspectors....

- Enter private property without a warrant.
- Take your property, at their discretion.
- Dispose of your property at will.
- Seize your bank accounts.
- Charge owners shipping & storage for seized property.
- Be empowered to store your property indefinitely and not reimburse you for your losses.

If you disobey these new regulations, you can be fined up to 5 Million dollars, and or 2 years in jail, or both. Bill C-51 is designed to bankrupt and silence the people.

This is reminiscent of what took place in Nazi Germany during the Hitler regime, when the laws of the land were changed. However in Germany they attacked only the Jews, but in Canada they intend to attack "all" Canadians. If the health foods are removed from the counters, you can expect the cost of prescriptions, will increase, dramatically. The mark-up on some of our prescription drugs today, is

absolutely unconscionable. Between what it cost to produce a drug, and what the consumer has to pay, is absolutely ridiculous. The cost to the consumer (based on drugs sold at Costco, USA) have shown markups (over the cost of the active ingredient) of 224%(PROZAC) or 569%(ZANAX) or even 4000% (ZOCOR). So is it any wonder why the pharmaceuticals are raking in billions of dollars, year after year, and they still wish to deny senior citizens, living on fixed incomes, the privilege of buying reasonably priced Health Foods & Supplements, they so desperately need for survival.

And there is no guarantee, when purchasing prescription drugs, that they won't be detrimental to your system! For years doctors have been prescribing prescriptions that have created serious side effects, leading to ill health and in some cases, even death. Maybe it's about time doctors were being investigated too.

Tony Clement, Federal Health Minister, is an all powerful prohibitionist pharmaceutical mogul, who owns 25% equity of Prudential Chem. Inc., a Toronto manufacturer of pharmaceutical chemicals. If this is not a blatant conflict of interest, then I don't know what is. Clement has breached the public's trust, and should be removed as Federal Minister of Health, immediately, if not sooner. I have followed the movement of governments for a number of years, and must consider this as one of the most shameful examples of how undemocratic, our federal governments really are. It's time to act now, and take the federal government to task over this most discriminating issue. •

Getting to the root of the problem...

"Cures do not result from treating symptoms. The cause must be addressed. While Climate Change has captured public attention, it is a symptom of a greater challenge. That challenge is that the human species has grown to fill its planet," says Nickerson from his home in rural Lanark, ON.

"It is odd," he continues, "at a time when our biggest problems

are the result of our size, that our leaders maintain that more growth is the solution. Like adolescents approaching

adulthood, our society clings to its carefree past. Since most adults have been able to make that transformation successfully, there is good reason to believe that our society will also accept its maturity."

Nickerson's latest book, "Life, Money & Illusion: Living on Earth as if we want to stay," details the differing views on how to be successful in our changing times. One view, the "Life" perspective, says we need to preserve and enhance ecosystems and communities; the other, the "Money" perspective, says we need to continuously expand production and consumption. These two approaches differ significantly on how they would deal with today's most serious problems.

*Life, Money & Illusion*, a 2007 Nautilus Book Award finalist, suggests a way forward, offering up new ways of organizing mutual provision (the economy) and a change in priorities that can lead to a long and joyous future. New Society Publishing has recently taken over distributorship.

During their discussions, while Nickerson looks at the big picture, Dillman, the Lanark area grandmother who went 68 days without eating last fall, to protest uranium exploration and mining in eastern Ontario, speaks to an 'on the ground' example of what needs changing. She says, "Toilet train we must, if we are to assure an un-soiled world for our grandchildren."

In an out of court settlement finalized on March 19, 2008, Percy Schmeiser has settled his lawsuit with Monsanto. Monsanto has agreed to pay all the clean-up costs of the Roundup Ready canola that contaminated Schmeiser's fields. Also part of the agreement was that there was no gag-order on the settlement and that Monsanto could be sued again if further contamination occurred. Schmeiser believes this

precedent-setting agreement ensures that farmers will be entitled to reimbursement when their fields become contaminated with unwanted Roundup Ready canola or any other unwanted GMO plants.

Percy and Louise Schmeiser have celebrated over 55 years of marriage. In addition to operating a farm equipment

### Fair Vote Canada

BC referendum legislation tabled, but issues remain (March 6, 2008)

*Fair Vote Canada* congratulated BC Premier Gordon Campbell for tabling legislation to enable the May 2009 referendum on the proposed BC-STV voting system.

"The BC government has honoured its commitment to hold a second referendum in conjunction with the next provincial election," said FVC President Stephen Broscoe. "However, we are concerned that the referendum question will be determined by an order of the Lieutenant Governor in Council. In the 2005 referendum, the question was set by the Citizens' Assembly. We call upon the government to use the same referendum question from 2005, making it free from political interference."

FVC also criticized the retention of the undemocratic 60% threshold for the next referendum. "In 2005, nearly 58% of British Columbians voted to switch to BC-STV, which should have been more than adequate for adoption," said Broscoe. "Now, the 2009 elections will be contested with a voting system that was overwhelmingly rejected in the last referendum. A simple majority voting in favour of BC-STV this time should be sufficient for adoption of the new system." First-past-the-post misrepresents AB voters (Mar. 408) Ed Stelmach's Progressive Conservatives won 53% of the popular vote, but the voting system rewarded them with 88% of the seats. Almost half of the electorate voted for opposition parties, which now hold only 11 of the 83 seats in the legislature.

Had voters used a fair voting system, the PCs would have won about 44 seats, the Liberals 22, the NDP 7, Wild Rose Alliance 6 and the Green Party 4.

**Fair Vote Alberta** issued a statement highlighting the inequities for voters: "To put (the) results in perspective, it only took about 7,000 votes province-wide to elect a PC candidate. It took 31,000 votes to elect a Liberal MLA, and 40,000 votes to elect a representative of the NDP. The 64,000 voters who cast ballots for the Wild Rose Alliance were shut out completely, as were the 43,000 supporters of the Alberta Greens. It is no wonder that Albertans are tuning out, on a massive scale, when so few of their votes count."

Both *Fair Vote Alberta* and *Fair Vote Canada* called on the new government to convene a citizens' assembly on electoral reform, similar to those in BC and Ontario, and let the voters of Alberta decide in a referendum whether to adopt a fairer and more proportional voting system.

Minority government okay with voters Yet another poll [Jan. 28, 2008] shows that Canadians are increasingly comfortable with minority government, which is good news for proponents of fair voting systems. According to a Canadian Press Harris-Decima telephone poll, conducted during the third week of January, more people would find acceptable either a Conservative or Liberal minority government than a majority government by either party:

- 54% said a Conservative minority would be acceptable, while 49% said the same for a Conservative majority government.
- 59% said a Liberal minority would be acceptable, compared to 50% who said the same for a Liberal majority. [...] www.fairvote.ca \*

# Ethics Commissioner tries to stop Court review of her conflict of interest ruling re PM/cabinet

OTTAWA, May 21 - Democracy Watch released its response to federal Conflict of Interest and Ethics Commissioner Mary Dawson's motion which she filed in the Federal Court of Appeal in April. The motion is an attempt to stop a review by the Court of her ruling issued on Jan. 7, 2008, which concluded that, even when the Prime Minister's and his Cabinet ministers' own actions and the actions of their close associate Brian Mulroney are in question, they are not covered by the Conflict of Interest Act and it is fine for them: to choose whether an inquiry into the Mulroney-Schreiber situation will take place; to set the scope of the inquiry; to choose the inquiry commissioner(s) who will judge them and Mr. Mulroney, and; to control the legal proceedings against Karlheinz Schreiber even though he made allegations about them. [...]

Extraordinarily, Commissioner Dawson's motion claims that she did not even make a ruling concerning the Prime Minister and his Cabinet ministers, even though she sent the ruling in writing to Democracy Watch in response to the ruling sets out 12 decisions that lead to Commissioner Dawson's overall conclusion that it was not within her jurisdiction to even investigate the Prime Minister and his Cabinet ministers, let alone find them in a conflict of interest with regard to the Mulroney Schreiber situation. [...] Even Prime Minister Stephen Harper has acknowledged, and stated publicly, that he and all members of his government are in a conflict of interest concerning the Brian Mulroney-Karlheinz Schreiber situation, given that Mr. Mulroney acted until very recently as an adviser to the Prime Minister, Mr. Schreiber sent documents to the Prime Minister and named him in a court affidavit, and the government was involved in legal proceedings to extradite Mr. Schreiber to Germany. However, despite recognizing their own

This is possibly because they feel they're being manipulated into an unjust and illegal conflict because no shred of evidence exists to prove that Afghans had anything to do with 9/11. There is also the indisputable fact the Taliban were created, armed, and trained by American Intelligence for guerrilla warfare against the Russians.

Canadian soldiers fighting and dying to protect a burgeoning drug trade in Afghanistan Canada has a serious problem with illegal drugs. Periodic police raids on both secondary and primary schools have found quantities of illegal potions in classes as low as grade six in the school system, Afghanistan allegedly produces up to ninety percent of the opium and opium derivatives being smuggled worldwide. Canada is one of the recipients. I take violent exception to the thought of my grandchildren being exposed to this sickness.

The last year the Taliban were in power, opium production was practically wiped out. Since Karzai has been in power, opium production and export has risen to more than six thousand tons per annum. Since then, 8,000 or more Haitians have been murdered, including women and children. It seems, in this corporate-fascist world we now live in, our troops acquired some urban warfare training at the expense of the unfortunate Haitians. I suppose it could come in handy in Toronto one day.

The reason a strong, up-to-date Canadian military is required should be obvious. Canada, with an insignificant population, is blessed with huge territorial areas, which haven't even been explored yet. Unfortunately, our ownership is in dispute from rapacious, expansionist dictatorships on each side. Eventually, Canadians will have to defend our territory. At present we seem focussed on giving it away.

# Laws only apply to those who can't afford lawyers!

As noted in a Canadian Union of Public Employees media release issued (May 21 08), "The Trade, Investment and Labour Mobility Agreement (TILMA) between British Columbia and Alberta-and the B.C. legislation enabling itviolate the Canadian constitution by usurping the role of judges and endowing cabinet with too much power, says a leading trade law expert in a legal opinion released today. In the written opinion, Sack Goldblatt Mitchell lawyer Steven Shrybman says that the TILMA and the BC Liberal government's Bill 32 "confront basic constitutional norms, including the rule of law and democracy", by trumping the authority of both judges and parliaments."

# The key conclusions of Steven Shrybman's legal opinion on Bill 32/ TILMA are:

- **1.** Because Bill 32 purports to deal with matters of interprovincial trade, investment and labour mobility, it infringes federal constitutional authority with respect to trade and commerce under 91(2) of the Constitution Act, 1867.
- **2.** By imposing financial penalties and other sanctions on the province for the lawful actions of governments and other public bodies, TILMA and Bill 32 improperly fetter (tie the hands) of the legislature, municipalities and many other public bodies.
- **3.** By empowering ad hoc arbitral tribunals to adjudicate private claims concerning the otherwise lawful actions of government and other public bodies, Bill 32 improperly derogates from the authority and independence of Canadian superior courts, which is protected under s. 96 of the Constitution.
- **4.** By empowering Cabinet the discretionary power to nullify, through regulation, the application of provincial laws, Bill 32 offends constitutional limits on the delegation of legislative power to the executive. The courts have

named such provisions "King Henry VIII clauses" after the propensity of that monarch to arrogate legislative power by proclamation.

### War profiteering and the price of gas...

I can't make this up:

In a hotel room in Brussels, the chief executives of the world's top oil companies unrolled a huge map of the Middle East, drew a fat, red line around Iraq and signed their names to it.

The map, the red line, the secret signatures. It explains this war. It explains this week's rocketing of the price of oil to \$134 a barrel.

It happened on July 31, 1928, but the bill came due now. Barack Obama knows this. Or, just as important, those crafting his policies seem to know this. Same for Hillary Clinton's team. There could be no more vital difference between the Republican and Democratic candidacies. And you won't learn a thing about it on the news from the Fox-holes.

Let me explain. In 1928, oil company chieftains (from Anglo-Persian Oil, now British Petroleum, from Standard Oil, now Exxon, and their Continental counterparts) were faced with a crisis: falling prices due to rising supplies of oil; the same crisis faced by their successors during the Clinton years, when oil traded at \$22 a barrel.

The solution then, as now: stop the flow of oil, squeeze the market, raise the price. The method: put a red line around Iraq and declare that virtually all the oil under its sands would remain there, untapped. Their plan: choke supply, raise prices rise, boost profits. That was the program for 1928. For 2003. For 2008.

Again and again, year after year, the world price of oil has been boosted artificially by keeping a tight limit on Iraq's oil output. Methods varied. The 1928 "Redline" agreement held, in various forms, for over three decades. It was replaced in 1959 by quotas imposed by President Eisenhower. Then Saudi Arabia and OPEC kept Iraq, capable of producing over 6 million barrels a day, capped at half that, given an export quota equal to Iran's lower output.

In 1991, output was again limited, this time by a new red line: B-52 bombings by Bush Senior's air force. Then came the Oil Embargo followed by the "Food for Oil" program. Not much food for them, not much oil for us.

In 2002, after Bush Junior took power, the top ten oil companies took in a nice \$31 billion in profits. But then, a miracle fell from the sky. Or, more precisely, the 101st Airborne landed. Bush declared, "Bring'm on!" and, as the dogs of war chewed up the world's second largest source of oil, crude

doubled in two years to an astonishing \$40 a barrel and those same oil companies saw their profits triple to \$87 billion.

In response, Senators Obama and Clinton propose something wrongly called a "windfall" profits tax on oil. But oil industry profits didn't blow in on a breeze. It is war, not wind, that fills their coffers. The beastly leap in prices is nothing but war profiteering, hiking prices to take cruel advantage of oil fields shut by bullets and blood.

I wish to hell the Democrats would call their plan what it is: A war profiteering tax. War is profitable business – if you're an oil man. But somehow, the public pays the price, at the pump and at the funerals, and the oil companies reap the benefits. Indeed, the recent engorgement in oil prices and profits goes right back to the Bush-McCain "surge." The Iraq government attack on a Basra militia was really nothing more than Baghdad's leaping into a gang war over control of Iraq's Southern oil fields and oil-loading docks. Moqtada al-Sadr's gangsters and the government-sponsored greedsters of SCIRI (the Supreme Council For Islamic Revolution In Iraq) are battling over an estimated \$5 billion a year in oil shipment kickbacks, theft and protection fees.

The Wall Street Journal reported that the surge-backed civil warring has cut Iraq's exports by up to a million barrels a day. And that translates to slashing OPEC excess crude capacity by nearly half. Result: ka-BOOM in oil prices and ka-ZOOM in oil profits. For 2007, Exxon recorded the highest annual profit, \$40.6 billion, of any enterprise since the building of the pyramids. And that was BEFORE the war surge and price surge to over \$100 a barrel. It's been a good war for Exxon and friends. Since George Bush began to beat the war-drum for an invasion of Iraq, the value of Exxon's reserves has risen – are you ready for this? – by \$2 trillion. [...]

## The Fraser Institute and the economic philosophy that drives it

I see that the Fraser institute has put out its newest Ontario school rankings that Big Media seems to have no problem with disseminating. What is the Fraser Institute? It advertises itself as an independent organization that aims to redirect public attention to the role of competitive markets in providing for

the well being of Canadians. Its advisory Board is made up of economists and we need to focus on three important words: independent, redirect and economists.

Since its aim is to redirect society, it is misleading to call itself independent. With this purpose of changing society in its image, its use of the word "independent" can be viewed as propaganda intended to engender trust. In point of fact, it means only that it does not receive government funding. Its corporate members direct them and its advisors are economists.

Economists? The economic philosophy driving Western business and government holds that if barriers that might otherwise interfere in the profits of a corporation or industry are minimized or, better, removed altogether then all in society will benefit. That is why depredation of the most basic means of human life - breathable air, water aquifers, ocean and land wildlife systems, and peoples' capacity to produce - are all ignored in economic models which governments produce. A country's measurement of value is strictly monetary: its Gross Domestic Product (GDP) has nothing to do with its peoples' well being or happiness or the country's ability to care for its resources in order to nourish future generations.

The philosophy that once everything is turned over to Business then all will be provided for is a fallacy that deserves the garbage pile. The assets of the world's three richest billionaires are greater than those of the poorest 600 million people, the gap between rich and poor has widened dramatically, and Food Banks are in crisis. The wealthy protest that they support charities but, while the top 2% put

piles of money into charities that meet their requirements, the bottom 90% are caught up in the cultural insanity that, for example, sees small farmers removed from their holdings so that land can be devoted to monoculture for export (like pineapples) with the former landholders now employed for a pittance as laborers.

The corporations have direct access to governments and global financial institutions, help set trade rules, pay little tax, reap hefty subsidies, dump cheap food on the poor thus undermining local production, and have the latest information about markets and new technologies. They outmanoeuvre and impoverish the small independents. Corporations, seeing the need to have "independent" organizations sweeten their images, have established such with very credible sounding names. Some of these are: the Tobacco Research Institute Council, the American Council on Science and Health, the Alliance for Better Foods, the International Food Information Council, the Industrial Health Foundation and the Fraser Institute.

So what is the Fraser Institute doing judging our education system? There is no question that it has an agenda. The latest ranking shows clearly that it wants to shape society's opinion toward accepting that a school that can groom its students to achieve the highest mark in certain tests is the "best" one, the one that we should all try to get our students into. We are told that great time and attention was put on the grade nine students in Kemptville's St. Michaels, as they were repeatedly drilled on test questions. The students performed admirably and, on the basis of this performance in one grade, the school is ranked at the top of the heap.

What was neglected in the rest of their educational experience in order for this to happen? We are not told this. What the purpose of education might be is buried in the need to achieve a good ranking and attract more students. After all, government grants are based on the number of pupils.

The emphasis on test passing, a lonely, isolated, memory -

focused occupation, develops the left brain, to the detriment of the right brain which is the creative side. The whole person utilizes both; but it is left-brain technocrats that the corporatocracy wants. These are the ones who will passively work away in their cubicles, accepting orders and performing as commanded. Such traits also contribute towards the development of sought-after enforcers. These are the ones the Fraser Institute wants us to turn out. Its masters don't want a lively, creative, questioning populace. One author has written that their role model is China.

Former PR whiz John Stauber with Sheldon Rampton has written a book called "*Toxic Sludge is Good For You*." In it they lament:

"(W)e are the most conditioned, programmed beings the world has ever known. Not only are our thoughts and attitudes constantly being shaped and moulded, but our very awareness for this process is subtly erased ... It is an exhausting and endless task to keep explaining to people how most issues of conventional wisdom are scientifically implanted in the public consciousness by a thousand media clips a day."

What do you want your school to do to their brains? What kind of a world do you hope your children will create? Can we allow ourselves to question the Fraser Institute and other corporate manipulations?

Did you know that on average 70% of all race horses are slaughtered after their racing career is over? Almost 98% of those horses are good useful horses for show and pleasure riding and companionship.

I started riding at 10 years of age and have always wanted a horse. I dreamed that I would have the chance to become a horse owner, but I believed it would never happen. Well, one day, my Dad, Mom, my friend Amber and I were at the *Valentia Equestrian and Rescue Center* where I ride. The owners, Jim and Michelle Ward were talking about a horse that they wanted to rescue. The only thing stopping them was money. I started asking about the horse and got more and more interested. They said that the horse was a great horse! He was only 3 years old and they couldn't understand why he was going to the slaughterhouse. Well, that is when I remembered the money I had saved from looking

after my neighbour's dog. Separately we didn't have enough money, but together we could fund the rescue. So, we settled on owning half a horse each!

Before I knew it, I was on my way to pick up a horse that I hadn't even seen yet. Thinking about the fact that I was about to save one of 100,000 horses that go to the slaughter house each year brought a smile to my face.

When we arrived we found out that he was destined to be meat simply because he had a small callous from a cut on his back leg. Believe it or not this slight, physical imperfection was enough to kill him! You can't even see it unless you really know what you are looking for and you're ridiculously fussy!

I took one look at the horse and couldn't believe my eyes! He was stunning. Tall, brown and beautiful! What were they thinking? That is when I thought of the name Second Chance because I was giving him a second chance at life. Sadly, for the 999,000+ other horses headed for slaughter they are loaded on a two-story meat trailer meant for pigs and cattle. These trailers don't have enough room for the horses to hold their heads in their normal position. They are crammed into the trailer and are not given food or water. They are then driven to their death. Smelling death in the air, they often trample each other, hurting or even killing one another.

When they arrive at the slaughterhouse they are lowered one by one by their hind legs into a room called the kill box. A spike is driven through their skull and into their brain paralyzing them. Their throats are then slit and they are left to bleed. The horses usually don't die for about 10

minutes. In shock and in pain, the horse dies a very agonizing death. They are then lowered onto a conveyer belt where they are cut into pieces.

Many responsible race horse owners don't really understand how the slaughter house works or they would never agree to it. Of course, there are cases where a horse is injured beyond rehabilitation and it's only humane to put

them down. But, for other race horses that were not ever born for feed and way too young to die, like my horse Second Chance, there is no legitimate reason for them to be sent for slaughter. Like Chance, most race horses are only two years old or younger. Their bones are not yet fully developed and they are pushed to their limits. Sometimes, like Chance, they have nothing really wrong with them. They are just too slow or haven't lived up to the owner's

expectations. So, instead of taking the time to find a home for them, the meat market is a simple, hassle-free solution for an owner who really doesn't care. The race horse industry is known for many acts of inhumanity including drugging the horses.

I have seen first hand, through the rescue centre, how some of the injured race horses, even with broken bones, can be rehabilitated into excellent riding horses.

My feeling is that if you can't look after a horse and take the time to find a home for them, then you shouldn't have them. God put these animals on the earth to be used, not to

be thrown away and wasted. I'm not saying that there aren't legitimate uses for horse meat products, however, my issue is with young, robust, perfectly healthy animals that were not born for consumption.

My horse Second Chance rides like the wind! When we fly across the field – with his mane blowing in the wind - I know I've done a great thing! And he is already a winner – my 'meat' horse has won multiple ribbons at the local fairs! Maybe it's just me who sees a problem

with this – maybe its my passionate love for this magnificent animal – but I can't believe that a multi-million dollar industry like horse racing couldn't have a better plan for the creatures that fill their pockets with money!

Thank-you for choosing to publish my 14-year-old daughters' letter regarding the dark side of the horse racing business... I know my daughter's heart was revealed in this letter, but more so, what an absolute crime and tragedy she has exposed. I am sure it will shock many of your readers.

If only more of us could see the world through children's eyes, maybe then, we could start making better decisions as adults. Once again, I thank you.

## Private member's bill threatens Canada's Supreme Court

John Gray, Montreal QC

I (have sent) along this message to friends and acquaintances and in particular to those who live outside Quebec and especially to those who live west of Ontario...

Mr. Denis Coderre is a Liberal MP from the Montreal area and has, for many years, been a strong proponent for pushing the French language across Canada. He has now put forward a Private Member's Bill in Ottawa, which would oblige any Supreme Court nominee for this top court in Canada to be fluently bilingual. [A May 15th column by Elizabeth Thompson (in The Gazette), "MP Coderre to table bill requiring top court judges to be bilingual," summarizes this.]

There are several points that all Canadians should be aware of, within the context of the linguistic demographics in Canada, where 97% of the French speakers in the country live in Quebec and 3% in the Rest of Canada

- The French population in Quebec, as a group, do not care one bit about the English population in Canada and especially those who live in Quebec. [One has only to see what has happened since the mid 1970's to the English people (of which I am one) in this province. The rights of English speakers have been eroded to the extent that everyone has to bow down to the French language; English has been virtually eliminated from the public arena in Quebec, which partially explains why about 500,000 English persons have left the province since the mid 1970's. It also helps to explain why 61% of the young English speaking undergraduates from Quebec universities have left or are currently planning to leave Quebec. (A May 16th column by Thompson entitled "Best and brightest Anglos leave Quebec" details this.)
- Of course, as a result of the above, the English population in Quebec has found out that if they wish to live in this province they must no longer fight "against the tide" and as a result the only English newspaper of any size left in Quebec The Montreal Gazette now follows the policy of ingratiating itself to the French majority. As a result, The Gazette in a recent editorial supports the view of Mr. Coderre (the May 13th editorial was entitled "High-court bilingualism is supremely desirable").
- An Editorial from Friday's National Post, entitled "Denis Coderre's bad idea," expresses ideas – such as "intellectual calibre and bipartisan credibility" being more important than language fluency - with which, I

believe, most thinking Canadians outside Quebec would agree.

■ To add a little more perspective to the issue, refer to pages 100 to 104 from Reed Scowen's recent book, "Time to Say Goodbye – building a better Canada without Quebec;" the whole book (revised 2nd edition) is well worth reading - it can be bought anywhere for about \$20----but the pages referred to above are germane to the present issue

The thinking of Coderre reminds me of the story of the lifeguard at the swimming pool who, when questioned as to why he had not jumped into the pool to save the drowning swimmer, replied that he could not swim. And when asked the obvious follow up question, "If that were true then how did you get the job?" he replied it was because he was bilingual.

Surely Canadians outside Quebec, sooner or later, have to resolve the issue of bilingualism being a mandatory prerequisite for an increasing number of employment situations.

For those who may read this, who do not personally know me, I have to say that, whatever the outcome is, it won't affect me – I'm far too old; but I do worry about the generation which follows me and the one after that.

PNWER FOUNDATION HISTORY:

The articles of ratification were passed in 1991 by similar statutes in the four states of Idaho, Montana, Oregon, and Washington. Alaska passed these same articles by action of its legislative council.

# British Columbia adopted them by ministerial action, and Alberta passed them by government resolution.

Amendments were passed in 1994, adding the governors and premiers, and updating other positions of the statutes. PNWER incorporated official private sector participation – including the non-elective public sector, and nonprofit organizations and NGOs in 1994 with that, a private sector council mirroring that of the organization's legislative delegate council was established and private and public sector co-chairs became part of the working group structure. Since then, funding for PNWER has been balanced by the public

and private sector. The organization's (2006) annual budget is U.S. \$900,000, with approximately one third coming from state and provincial dues, one third from private sector sponsorship and dues, and one third from public and private grants.

(Note meetings are not open to public nor proceedings picked up by media, the plans are being implemented without public consultation or knowledge)

## Energy (think privatization of power production, private water licenses to produce power on the rivers of BC)

PNWER's energy program is funded in part by the US Department of Energy; the Alberta Ministry of Energy; British Columbia Ministry of Energy, Mines and Petroleum Resources, and various private sector stakeholders. The overall goal of the Bi-National Regional Energy Planning Initiative is to engage regional public and private sector stakeholders in a dialogue about the region's energy future. Initiatives: To lead this effort, PNWER has convened a Legislative Energy Chairs/Provincial Energy Ministers Task Force, is developing an Energy 101 Project in conjunction with the National Conference of State Legislatures, is disseminating information on the implementation of the corridor provisions of the Energy Policy Act of 2005, is analyzing current and proposed energy infrastructure projects, is engaged in an effort to develop better tools to analyze resource and transmission planning in the bi-national region, and will monitor state and provincial legislative developments on behalf of its stakeholders.

- 1. Every person has cancer cells in the body. These cancer cells do not show up in the standard tests until they have multiplied to a few billion. When doctors tell cancer patients that there are no more cancer cells in their bodies after treatment, it just means the tests are unable to detect the cancer cells because they have not reached the detectable size.
- **2.** Cancer cells occur between 6 to more than 10 times in a person's lifetime.
- **3.** When the person's immune system is strong, the cancer cells will be destroyed and prevented from multiplying and forming tumours.
- **4.** When a person has cancer it indicates the person has multiple nutritional deficiencies. These could be due to genetic, environmental, food and lifestyle factors.
- **5.** To overcome the multiple nutritional deficiencies, changing diet and including supplements will strengthen the immune system.
- 6. Chemotherapy involves poisoning the rapidly-growing cancer cells and also destroys rapidly-growing healthy cells in the bone marrow, gastro-intestinal tract etc, and can cause organ damage, like liver, kidneys, heart, lungs, etc.
- **7.** Radiation, while destroying cancer cells, also burns, scars and

damages healthy cells, tissues and organs.

- **8.** Initial treatment with chemotherapy and radiation will often reduce tumor size. However, prolonged use of chemotherapy and radiation do not result in more tumor destruction.
- **9.** When the body has too much toxic burden from chemotherapy and radiation, the immune system is either compromised or destroyed, hence the person can succumb to various kinds of infections and complications.
- **10**. Chemotherapy and radiation can cause cancer cells to mutate and become resistant and difficult to destroy. Surgery can also cause cancer cells to spread to other sites.
- **11.** An effective way to battle cancer is to starve the cancer cells by not feeding it with the foods it needs to multiply.

#### **CANCER CELLS FEED ON:**

**a. Sugar** is a cancer-feeder. By cutting off sugar it cuts off one important food supply to the cancer cells. Sugar substitutes like NutraSweet, Equal, Spoonful, etc are made with Aspartame and it is harmful. A better natural substitute would be Manuka honey or molasses but only in very small

amounts. Table salt has a chemical added to make it white in colour. Better alternative is Bragg's aminos or sea salt.

- **b. Milk** causes the body to produce mucus, especially in the gastro-intestinal tract. Cancer feeds on mucus. By cutting off milk and substituting with <u>unsweetened</u> soya (or rice, nut, hemp, etc.) milk cancer cells are being starved.
- **c. Meat: cancer cells thrive in an acid environment**. A meat-based diet is acidic and it is best to eat fish, and a little chicken rather than beef or pork. Meat also contains livestock antibiotics, growth hormones and parasites, which are all harmful, especially to people with cancer.
- **d.** Avoid coffee, tea, and chocolate, which have high caffeine. Green tea is a better alternative and has cancer-fighting properties. Water-best to drink purified water, or filtered, to avoid known toxins and heavy metals in tap water. Distilled water is acidic, avoid it.
- **12.** Meat protein is difficult to digest and requires a lot of digestive enzymes. Undigested meat remaining in the intes-

tines become putrified and leads to more toxic buildup.

- 13. Cancer cell walls have a tough protein covering. By refraining from or eating less meat it frees more enzymes to attack the protein walls of cancer cells and allows the body's killer cells to destroy the cancer cells.
- 14. Some supplements build up the immune system (IP6, Flor-ssence, Essiac, anti-oxidants, vitamins, minerals, EFAs, etc.) to enable the body's own killer cells to destroy cancer cells. Other supplements like

vitamin E are known to cause apoptosis, or programmed cell death, the body's normal method of disposing of damaged, unwanted, or unneeded cells.

- **15.** Cancer is a disease of the mind, body, and spirit. A proactive and positive spirit will help the cancer warrior be a survivor. Anger, unforgiveness and bitterness put the body into a stressful and acidic environment. Learn to have a loving and forgiving spirit. Learn to relax and enjoy life.
- **16.** Cancer cells cannot thrive in an oxygenated environment. Exercising daily, and deep breathing help to get more oxygen down to the cellular level. Oxygen therapy is another means employed to destroy cancer cells.
